CHAPTER 322.

AN ACT to amend section 1 and to repeal and recreate section 2 of chapter 238, laws of 1937, relating to the conveyance to the city of Oshkosh of certain submerged lands for harbor purposes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 1 of chapter 238, laws of 1937 is amended to read:

(Chapter 238, Laws of 1937) Section 1. All right, title, and interest of the state of Wisconsin in and to the lands submerged beneath the waters of Miller's Bay, being a part of Lake Winnebago, lying west of a line drawn from the point of land south of the harbor of Refuge Island, constructed by the United States government and deeded to the city of Oshkosh by the war department on April 27, 1932, and by the state of Wisconsin by order number two thousand nine hundred twenty-nine of the commission of public lands, dated March 19, 1931, to Lake Court, and including all that reef known as Horseshoe Island; said submerged lands being part of fractional lot number one of section nineteen and fractional lots number two, number three, and number four of section eighteen, township eighteen north, range seventeen east, Winnebago county, Wisconsin, are hereby granted to the city of Oshkosh for the purpose of erecting thereon a pier and breakwater, enclosing a harbor for navigation purposes. * * * *The pier and breakwater may be erected at any desirable location within or along the easterly boundary of the area so granted to the city of Oshkosh.*

SECTION 2. Section 2 of chapter 238, laws of 1937 is repealed and recreated to read:

(Chapter 238, Laws of 1937) Section 2. The pier and breakwater shall have such openings and bridges as may be prescribed by the public service commission, and plans for the structure shall be approved by the public service commission. The following are the proposed dimensions of the pier and breakwater: A breakwater extending from a point four hundred feet northeast of said Refuge Island; thence continuing in a northeasterly direction along or within the easterly line of the above granted lands for a distance of twelve hundred feet; to a point on the

most easterly extension at low water mark of the present reef known as Horseshoe Island; thence in a northerly direction twenty nine hundred feet to a point that is one hundred feet west of the west line of Lake Court; said breakwater not to exceed thirty feet in width on top, the whole to be so constructed as to form a harbor for boats. However, the aforesaid proposed dimensions of the pier and breakwater, as to length, direction and location may be modified by ordinance or resolution of the governing body of the city of Oshkosh at any time, subject to the approval of the public service commission as far as openings, bridges and plans for the structure are concerned.

CHAPTER 323.

AN ACT to amend 100.21 and 100.30 (2) (j), (3) and (4) of the statutes, relating to unfair trade practices, and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 100.21 of the statutes is amended to read:

100.21 Any person, *corporation, partnership or business* * * * suffering pecuniary loss because of a violation by any other person of any order issued under section 100.20 may sue such person, *corporation, partnership or business*, for damages therefor in any court of competent jurisdiction and shall recover twice the amount of such pecuniary loss, together with costs, including a reasonable attorney's fee.

SECTION 2. 100.30 (2) (j), (3) and (4) of the statutes are amended to read:

100.30 (2) (j) When one or more items are advertised, offered for sale, * * * sold * * * or * * * offered as a gift, or given *tied in or combined* with the sale of one or more other items, * * * the price of each item * * * shall be * * * *subject to the requirements* of subsection (2) (a) or (b) hereof.

(3) Any advertising, offer to sell, or sale of any *item of merchandise* either by retailers or wholesalers, at less than cost as defined in this section * * * *and any advertising, offer to give,*
