CHAPTER 45.

AN ACT to amend 324.18 (2) of the statutes, relating to waiver of notices by guardians.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

324.18 (2) of the statutes is amended to read:

324.18 (2) Persons who are sui juris, and duly appointed and qualified guardians ad litem in behalf of themselves and those for whom they are acting, may in writing waive the service of notice upon them and consent to the hearing of any matter without notice except that a guardian ad litem shall not waive the notice for a petition to prove a will or the petition for administration.

CHAPTER 46.

AN ACT to create 84.01 (24) of the statutes, relating to the destruction of obsolete records in the highway commission.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

84.01 (24) of the statutes is created to read:

84.01 (24) **DESTRUCTION OF OBSOLETE RECORDS.**

Whenever necessary to gain needed vault, filing or storage space, the commission may turn over to the director of purchases for destruction, obsolete records in conformity with the time limit shown opposite the following classifications: General correspondence, after 10 years; county requisitions for reimbursement and supporting material, after 10 years; town, village and city plat maps and mileage lists, after 2 years and microfilming; county construction reports under state aid law prior to 1925, after 15 years; employes' time and expense distribution reports, after 5 years; I. B. M. distribution and summary tabulating cards, after one year as directed by the commission; contractors' statements pursuant to section 66.29 (2), after 5 years; contractors' transcripts of labor pay rolls, after

one year from the completion of the contract; bridge and highway plans, after 10 years from the completion of the survey and after microfilming.

CHAPTER 47.

AN ACT to amend 44.03 of the statutes, relating to local historical societies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

44.03 of the statutes is amended to read:

44.03 Local societies without capital stock may be incorporated for any purposes mentioned in section 44.02, and as auxiliaries to the state historical society, to gather and preserve * * * *the books, documents and artifacts relating to the history of their region or locality.* No fees shall be charged by any register of deeds for recording nor by the secretary of state for filing the articles of organization or any amendments thereto, * * * or for a certificate of incorporation of any such society.

CHAPTER 48.

AN ACT to amend 44.05 of the statutes, relating to collections of auxiliary historical societies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

44.05 of the statutes is amended to read:

44.05 Any such auxiliary society may make a report of its work annually to said state historical society, which, or portions or a synopsis thereof, may be included in the publications of said state society, and upon application of any auxiliary society the state society may become, in behalf of the state, the custodian of the records *and collections* of such auxiliary society.
