CHAPTER 49.

AN ACT to amend 20.33 (8) (b) and 41.215 of the statutes, authorizing payment of costs of administration incurred by the state board of vocational and adult education from federal aid under the federal vocational educational program, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.33 (8) (b) of the statutes is amended to read:

20.33 (8) (b) The state board of vocational and adult education is authorized to receive money from the federal veterans administration under the provisions of U. S. Public Law No. 16, chapter 22, 1st session 78th Congress and U. S. Public Law No. 346, chapter 268, 2nd session, 78th Congress and any acts amendatory thereof or supplementary thereto, which shall be paid within one week after receipt into the general fund and is appropriated therefrom to said board to be paid as reimbursements to local boards of education or boards of vocational and adult education in the amounts due each respective local board for training students, *and for defraying costs of administration by the state board of vocational and adult education*, as provided under section 41.215.

SECTION 2. 41.215 of the statutes is amended to read:

41.215 The state board of vocational and adult education is authorized to enter into contracts with the federal veterans administration when so authorized by a local board of education or a board of vocational and adult education for training to be provided by the local boards of education or boards of vocational and adult education in the field of vocational agriculture to veterans eligible for benefits under the provisions of U. S. Public Law No. 16, chapter 22, 1st session, 78th Congress and U. S. Public Law No. 346, chapter 268, 2d session, 78th Congress and any acts amendatory thereof or supplementary thereto and to receive from the federal veterans administration such payments for tuition, supplies, materials and services, as may be granted to cover the cost of such training, *and for costs of administration by the state board of vocational and adult education*. All payments received by the state board of vocational and adult education under the provisions of this

section shall be paid within one week after receipt into the general fund and are appropriated therefrom to said board under section 20.33 (8) (b) to be expended as provided in this section.

CHAPTER 50.

AN ACT to amend 67.04 (1) (h) and to create 67.04 (1) (r) of the statutes, relating to authorization of bond issues by counties to provide for the purchase of lands and construction of housing for sale or rental for veterans.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 67.04 (1) (h) of the statutes is amended to read:
67.04 (1) (h) To acquire land for county parks *and to improve the same.*

SECTION 2. 67.04 (1) (r) of the statutes is created to read:
67.04 (1) (r) To provide funds for acquiring land by purchase or condemnation and constructing thereon or upon lands otherwise acquired by the county, various types of housing to be sold or rented, upon such terms as the county board may authorize, to honorably discharged members of the armed services of the United States who served in any of its wars and who at the time of induction into such service were residents of such county.
