CHAPTER 51.

AN ACT to repeal certain paragraphs of the standard town mutual policy as contained in 202.085, to repeal 202.086 and to amend 202.085 (introductory paragraph) of the statutes, relating to notice of fire loss on standard town mutual policies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 202.085 (introductory paragraph) of the statutes is amended to read:

202.085 (introductory paragraph) The commissioner of insurance shall prepare and file in his office printed forms, *sizes 8-1/2 x 14 inches and 9 x 15-1/2 inches*, in blank of a policy of insurance *containing the context, provisions, agreements and conditions specified in this section, to be known as the "Standard Town Mutual Policy" and to be used only by companies organized or operating under this chapter * * *. Any such company may at its option use either size.* No town mutual insurance company, its officers or agents, shall make, issue, use or deliver for use any insurance policy other than such as shall conform in all particulars as to form, context, provisions, agreements and conditions with the printed forms of policy so filed in the office of the commissioner of insurance. No other or different provision, agreement, conditions or clause shall in any manner be made a part of said policy except as follows, to wit: (1) the name of the company, (2) its location or place of business, (3) the date of its organization, (4) the name of its officers, (5) the number and (6) date of the policy, (7) the standard articles of organization and by-laws, and (8) such printed riders, permits, and descriptive forms as shall necessarily be attached to such policy; provided, however, that such by-laws, riders and permits shall in no case be inconsistent with or a waiver of any of the conditions of the standard policy herein provided for.

SECTION 2. The second paragraph of the "Notice" on the filing face of the standard town mutual policy reading:

"In case of a fire loss be sure to send the rider attached to this Policy to State Fire Marshal, Madison, Wis.; or Chief of Fire Department where there is a fire department," is repealed.

SECTION 3. The paragraph entitled "Notice of Fire Loss" in the standard town mutual policy is repealed.

SECTION 4. 202.086 of the statutes is repealed.

CHAPTER 52.

AN ACT to amend 5.05 (5) (b) and 6.60 (3) and to create 5.04 (5) of the statutes, relating to election administration.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 5.04 (5) of the statutes is created to read:

5.04 (5) Subsections (3) and (4) shall not be applicable in any city, village or town where publication of such notices is made as provided in 6.82 (2).

SECTION 2. 5.05 (5) (b) of the statutes is amended to read:

5.05 (5) (b) The affidavit of a qualified elector stating his residence with street and number if his residence has any street and number shall be appended to each such nomination paper, stating that he is personally acquainted with all persons who have signed the same, and that he knows them to be electors of that precinct, ward, town, village, *city* or county, as the nomination papers shall require; that he knows that they signed the same with full knowledge of the contents thereof and that their respective residences are stated therein and that each signer signed the same on the date stated opposite his name, and that he, the affiant, resides within the district which the candidate (named therein) will represent if elected and that he intends to support such candidate. Such affidavit shall not be made by the candidate, but each candidate shall file with his nomination paper or papers, a declaration that he will qualify as such officer if nominated and elected.

SECTION 3. 6.60 (3) of the statutes is amended to read:

6.60 (3) Before separating, the inspectors shall fold in two folds and string closely upon a single piece of flexible wire, all ballots which shall have been counted by them, except those marked "Objected To," unite the ends of such wire in a firm knot, *or each set of ballots shall be tied securely in bundles,*
