**CHAPTER 94.**

AN ACT to amend 40.19 (1) of the statutes, relating to teacher's travel expense.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

40.19 (1) of the statutes is amended to read:

40.19 (1) The common school board shall contract in writing with qualified teachers, which contract, with a copy of the teacher's authority attached thereto, shall be filed with the clerk. *Such contract, in addition to fixing the teacher's wage, may provide for compensating the teacher for necessary travel expense in going to and from the schoolhouse at a rate not to exceed 6 cents per mile.* No teaching contract with any person not legally authorized to teach the named school or subject shall be valid; and all teaching contracts shall terminate if, and when, the authority to teach terminates.

**CHAPTER 95.**

AN ACT to amend 29.578 (9) of the statutes, relating to live deer shipping tags.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

29.578 (9) of the statutes is amended to read:

29.578 (9) Such licensee may sell and transport live deer providing that the conservation commission or one of its representatives be notified in advance of the shipment of such deer, and the conservation commission or its representatives shall make acknowledgment of receipt of said notice and such acknowledgment when received by the licensee shall be his authority for shipping deer. The licensee shall pay to the commission \$1 for each live deer sold, and each crate or conveyance carrying such live deer must have a special tag \* \* \* or tags attached thereto for each live deer transported therein, showing that it is a deer from a deer farm. *The data on such*

*tag or tags shall be entered in ink or indelible pencil and such tag or tags shall be retained by the purchaser of said live deer.* Such tags shall be furnished by the conservation commission, its deputies or agents.

59.08 (22m) Appropriate money to defray the expense of participation by the county in the state centennial celebration or observance within the county.

### CHAPTER 97.

AN ACT to repeal 20.43 (8); to amend 158.04 (5) (e), 158.05 (2), 158.09 (6), 158.11 (1) (b), 158.11 (3), 158.12 (2) (b) and (4); and to repeal and recreate 158.06 and 158.10 (4) of the statutes, relating to barbers and providing penalties.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 20.43 (8) of the statutes is repealed.

SECTION 2. 158.04 (5) (e) of the statutes is amended to read:

158.04 (5) (e) To operate a barber shop in connection with any other business or dwelling unless there is a substantial, dust or odor-proof partition or wall from the floor to the ceiling, separating the barber shop from such other business or dwelling. Access to the barber shop shall be by means of a separate
