## CHAPTER 77

AN ACT to amend 70.11 (2) and 198.10 (5); and to create 76.02 (13) of the statutes, relating to taxation of municipal power districts.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 70.11 (2) of the statutes is amended to read:

70.11 (2) Property owned by any county, city, village, town \* \* \*, school district, *municipal water district created under s. 198.22 or town sanitary district;* lands belonging to cities of any other state used for public parks; land tax-deeded to any county or city before the first Monday in July.

SECTION 2. 76.02 (13) of the statutes is created to read:

76.02 (13) Nothing in this chapter contained shall be construed to result in the levy, assessment, or collection of taxes on property of a municipal water utility created under s. 198.22.

SECTION 3. 198.10 (5) of the statutes is amended to read:

198.10 (5) All utility property of every municipal power district, except a municipal water district created under s. 198.22, shall be assessed and taxed in the manner provided by law for the assessment and taxation of privately owned public utilities.
