CHAPTER 66

- AN ACT to renumber Titles XXX and XXXI and chapters 325 to 336 of the statutes; and to amend various sections of the statutes to delete surplus words.
- The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
