CHAPTER 2, LAWS OF 1969

AN ACT to repeal 10.32 (4) (f) and (5) (e); to renumber 10.32 (1) (b); to renumber and amend 8.20 (8); to amend 8.50 (3) (a); to repeal and recreate 10.32 (2) (e), (4) (e) and (5) (d); and to create 8.20 (8) (b) and 10.32 (1) (b) 2 of the statutes, relating to the period for circulating nomination papers for independent candidates at partisan special elections.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 8.20 (8) of the statutes is renumbered 8.20 (8) (a) and amended to read:

8.20 (8) (a) Nomination papers for independent candidates, ~~shall for any office to be voted upon at a general election may~~ be circulated no sooner than August 1 preceding the election and shall be filed not later than 5 p.m. on the 3rd Tuesday in September.

SECTION 2. 8.20 (8) (b) of the statutes is created to read:

8.20 (8) (b) Nomination papers for independent candidates for any office to be voted upon at a partisan special election shall be circulated and filed as provided in s. 8.50 (3) (a).

SECTION 3. 8.50 (3) (a) of the statutes is amended to read:

8.50 (3) (a) Nomination papers shall be circulated no sooner than the day the order for the special election is filed and shall be filed not later than 5 p.m. 18 days before the day of the special primary. *Nomination papers for independent candidates for an office to be voted upon at a partisan special election may be circulated no sooner than 14 days prior to the day of the special primary and shall be filed not later than 5 p.m. 7 days after the day of the special primary.*

SECTION 4. 10.32 (1) (b) of the statutes is renumbered 10.32 (1) (b) 1.

SECTION 5. 10.32 (1) (b) 2 of the statutes is created to read:

10.32 (1) (b) 2. For independent candidates at a partisan special election, nomination papers may be circulated no sooner than 14 days prior to the special primary and shall be filed no later than 5 p.m. 7 days after the special primary. See s. 8.50 (3).

SECTION 6. 10.32 (2) (e) of the statutes is repealed and recreated to read:

10.32 (2) (e) *Nomination papers.* 1. Nomination papers may be circulated no sooner than the day the order for the special election is filed and shall be filed no later than 5 p.m. 18 days before the special primary. See s. 8.50 (3).

2. For independent candidates at a partisan special election, nomination papers may be circulated no sooner than 14 days prior to the special primary and shall be filed no later than 5 p.m. 7 days after the special primary. See s. 8.50 (3).

SECTION 7. 10.32 (4) (e) of the statutes is repealed and recreated to read:

10.32 (4) (e) *Nomination papers.* 1. Nomination papers may be circulated no sooner than the day the order for the special election is filed and shall be filed no later than 5 p.m. 18 days before the special primary. See s. 8.50 (3).

2. For independent candidates at a partisan special election, nomination papers may be circulated no sooner than 14 days prior to the special primary and shall be filed no later than 5 p.m. 7 days after the special primary. See s. 8.50 (3).

SECTION 8. 10.32 (4) (f) of the statutes is repealed.

SECTION 9. 10.32 (5) (d) of the statutes is repealed and recreated to read:

10.32 (5) (d) *Nomination papers.* 1. Nomination papers may be circulated no sooner than the day the order for the special election is filed and shall be filed no later than 5 p.m. 18 days before the special primary. See s. 8.50 (3).

2. For independent candidates at a partisan special election, nomination papers may be circulated no sooner than 14 days prior to the special primary and shall be filed no later than 5 p.m. 7 days after the special primary. See s. 8.50 (3).

SECTION 10. 10.32 (5) (e) of the statutes is repealed.
