CHAPTER 411, LAWS OF 1969

AN ACT to repeal, renumber, amend and consolidate various provisions of the statutes for the purpose of correcting errors, supplying omissions, clarifying language, correcting references, eliminating duplications, reconciling conflicts and repelling unintended repeals (Revisor's Correction Bill).

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 235.185 of the statutes, as created by chapter 14, laws of 1969, is renumbered 706.065.

SECTION 2. The amendment of 253.10 (1) of the statutes by chapter 339, laws of 1969, is not repealed by chapter 283, laws of 1969. Both amendments stand.

SECTION 3. 299.30 (3) (b) of the statutes, as created by chapter 284, laws of 1969, is amended by substituting "writ of restitution" for "writ of restriction".

SECTION 4. 312.03 of the statutes, as amended and renumbered 323.21 by chapter 339, laws of 1969, and 312.03 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.191.

SECTION 5. 312.08 of the statutes, as amended and renumbered 323.23 by chapter 339, laws of 1969, and 312.08 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.245.

SECTION 6. 312.11 of the statutes, as amended and renumbered 323.25 by chapter 339, laws of 1969, and 312.11 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.192.

SECTION 7. 312.13 of the statutes, as amended and renumbered 323.27 by chapter 339, laws of 1969, and 312.13 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.193.

SECTION 8. 318.06 (9) of the statutes, as amended by chapter 285, laws of 1969, is repealed.

SECTION 9. 324.35 of the statutes, as amended and renumbered 323.32 by chapter 339, laws of 1969, and 324.35 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.251.

SECTION 10. 324.351 of the statutes, as amended and renumbered 323.34 by chapter 339, laws of 1969, and 324.351 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.252.

SECTION 11. 324.356 of the statutes, as amended and renumbered 323.36 by chapter 339, laws of 1969, and 324.356 of the statutes, as amended by chapter 283, laws of 1969, are consolidated and renumbered 319.253.

SECTION 12. 701.13 (5) (d) of the statutes, as created by chapter 283, laws of 1969, is amended to read:

701.13 (5) (d) Any veteran's organization incorporated by act of congress, or ~~if~~ *any* of its departments or local chapters or posts, no part of the net earnings of which inures to the benefit of any private shareholder or individual.

SECTION 13. 853.17 (2) of the statutes, as created by chapter 339, laws of 1969, is amended by substituting "s. 701.09" for the reference to "s. 231.49".

SECTION 14. Wherever the words "this act" appear in the following sections, all as renumbered by chapter 334, laws of 1969, the words "this chapter" are substituted: 703.02 (1), (7) (b), (9) and (13), 703.03, 703.06

(3), 703.09 (1), 703.11 (10) and (11), 703.12 (5), 703.15, 703.17, 703.19 (12) and 703.22 (2).

SECTION 15. SECTION 16 of chapter 334, laws of 1969, is renumbered 700.25.

SECTION 16. This act shall take effect July 1, 1971.
