AN ACT to repeal 43.03; to renumber 43.015, 43.02, 43.04 to 43.06, 48.09, 48.10, 251.181, 251.183, 251.1835, 252.08, 253.185, 253.20, 253.21 (1), 256.31, 256.325, 256.54, 256.59 and 256.67; to renumber and amend 43.01; and to create chapter 257 (title) and 257.01 (2) of the statutes, relating to judicial branch agencies and committees.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 43.01 of the statutes is renumbered 257.01 (1) and amended to read:

257.01 (1) The justices of the supreme court and the attorney general or his representative shall be ex officio trustees of the state library, and may make and enforce, by suitable penalties, such rules and regulations for the <u>management of the library and the</u> custody, superintendence, care and preservation of the books and other property contained in said the library, and for the arrangement thereof as to -said the trustees shall -seem deem necessary and proper.
