## **CHAPTER 218, Laws of 1975**

AN ACT to amend various provisions of the statutes for the purpose of correcting errors, clarifying language and eliminating distinctions based upon sex as authorized by section 13.93 (1) (m) of the statutes (Revisor's Correction Bill).

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

PREFATORY NOTE: Section 13,93 (1) (m) of the statutes, created by chapter 94, laws of 1975, directs the revisor of statutes to replace personal pronouns, words of male or female gender and other terminology which discriminates on the basis of sex, except where the statute clearly applies to one sex only, whenever any statute is affected by any act of the legislature. The revisor also may make these changes in statutes which are not affected According to s. 13.93 (1) (m), these changes have no substantive effect. This bill removes language which discriminates on the basis of sex from statutes created or affected by Supreme Court order under the authority of s. 251.18 of the statutes, relating to rules of pleading and practice. The statutes covered in this bill were those affected by Supreme Court order adopted February 17, 1975, promulgating rules of civil procedure, modifications to the rules adopted September 30, 1975 and rules of videotape procedure adopted the same date, all effective January 1, 1976. Rules of pleading and practice adopted by the court under s. 251.18 are specifically subject to amendment by the legislature. Those chapters of the statutes which were merely relocated by renumbering are not covered in this bill and neither are amendments to court rules which are designated "rule" in the statutes. Nearly all the changes in this bill relate to deleting pronouns, substituting nouns for pronouns or changing words to delete references to A few errors also are corrected. This bill includes only those changes which the revisor believes have no question as to substantive effect. Those changes which appear to raise some question as to substantive effect will be presented in separate bills. Since the reason for the changes are similar for all sections, there are no notes to individual sections.

If the party joined moves for dismissal without prejudice as to his or her claim, he the party shall demonstrate to the court that it would be unjust to require him the party to prosecute his the claim with the principal claim. In determining whether to grant the motion to dismiss, the court shall weigh the possible prejudice to the movant against the state's interest in economy of judicial effort.
