CHAPTER 201, Laws of 1979

AN ACT to repeal 15.77 (2) (intro.); to renumber 15.77 (2) (a) to (f) and (3); to amend 15.77 (1), (2) (a) 1 and 2 and (b) and (3), as renumbered; and to create 15.77 (2) (a) (intro.) of the statutes, relating to reorganizing the law on appointment of members of the personnel board.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 15.77 (1) of the statutes is amended to read:

15.77 (1) There is created a personnel board ~~consisting of persons who shall be nominated by the governor, and with the advice and consent of the senate~~ appointed, for staggered 5-year terms as follows: one member shall be nominated by the governor; and one member ~~each~~ shall be nominated by the governor from ~~each~~ a list of 5 names submitted ~~individually~~ by the president ~~pro tempore~~ of the senate; one member shall be nominated by the governor from a list of 5 names submitted by the speaker of the assembly; one member shall be nominated by the governor from a list of 5 names submitted by the minority leader of the senate; and one member shall be nominated by the governor from a list of 5 names submitted by the minority leader of the assembly. ~~All of the persons on every list shall possess all of the qualifications under sub. (2) except that no more than 3 of the persons on every list need possess the qualification specified under sub. (2) (b).~~

SECTION 2. 15.77 (2) (intro.) of the statutes is repealed.

SECTION 3. 15.77 (2) (a) to (f) and (3) of the statutes are renumbered 15.77 (2) (a) 1, (3) (a), (2) (b) and (c), (3) (b), (2) (a) 2 and (4), respectively, and 15.77 (2) (a) 1 and 2 and (b) and (3), as renumbered, are amended to read:

15.77 (2) (a) 1. ~~All members shall have~~ Have an interest in the state civil service system.

2. ~~Each member of the board shall be~~ Be a United States U.S. citizen and shall have been a resident of this state for at least 3 years.

(b) ~~No member and no person on any list submitted to the governor under sub. (1) may hold any other position in state employment.~~

(3) (a) At least 3 members of the personnel board and at least 3 persons named on every list submitted to the governor under sub. (1) shall have at least 3 years' experience in professional work in personnel or labor relations.

(b) At no time may more than 3 members of the personnel board be adherents of the same political party.

SECTION 4. 15.77 (2) (a) (intro.) of the statutes is created to read:
