AN ACT to create 767.23 (1g), 767.24 (9), 767.325 (9) and 767.327 (7) of the statutes; and to affect 1987 Wisconsin Act (1987 Assembly Bill 205), section 73, relating to specifying the initial applicability for provisions relating to temporary legal custody, legal custody, periods of physical placement and visitation in actions affecting the family.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 767.23 (1g) of the statutes is created to read:

767.23 (1g) Notwithstanding 1987 Wisconsin Act (1987 Assembly Bill 205), section 73, as affected by 1987 Wisconsin Act (this act), the parties may agree to the adjudication of a temporary order under this section in an action affecting the family that is pending on the effective date of this subsection [revisor inserts date].

SECTION 2. 767.24 (9) of the statutes is created to read:

767.24 (9) APPLICABILITY. Notwithstanding 1987 Wisconsin Act (1987 Assembly Bill 205), section 73, as affected by 1987 Wisconsin Act (this act), the parties may agree to the adjudication of a custody or physical placement order under this section in an

action affecting the family that is pending on the effective date of this subsection [revisor inserts date].

SECTION 3. 767.325 (9) of the statutes is created to read:

767.325 (9) APPLICABILITY. Notwithstanding 1987 Wisconsin Act (1987 Assembly Bill 205), section 73, as affected by 1987 Wisconsin Act (this act), the parties may agree to the adjudication of a modification of a legal custody or physical placement order under this section in an action affecting the family that is pending on the effective date of this subsection [revisor inserts date].

SECTION 4. 767.327 (7) of the statutes is created to read:

767.327 (7) APPLICABILITY. Notwithstanding 1987 Wisconsin Act (1987 Assembly Bill 205), section 73, as affected by 1987 Wisconsin Act (this act), the parties may agree to the adjudication of a modifica-

tion of a legal custody or physical placement order under this section in an action affecting the family that is pending on the effective date of this subsection [revisor inserts date].

SECTION 5. 1987 Wisconsin Act (1987 Assembly Bill 205), section 73 is repealed and recreated to read:

- (1987 Wisconsin Act (1987 Assembly Bill 205)) Section 73. **Initial applicability.** This act applies to all of the following:
- (1) Any action commenced on or after the effective date of this subsection.

(2) Any petition, motion or order to show cause for a revision of legal custody or physical placement order under section 767.325 of the statutes or for moving a child's residence within or outside the state under section 767.327 of the statutes filed on or after the effective date of this subsection. A petition, motion or order to show cause filed under section 767.325 of the statutes or section 767.327 of the statutes may be for a revision of an order entered prior to the effective date of this subsection or for a revision of an order entered on or after the effective date of this subsection.
