NR 10.001 Definitions. (1) "Antlerless deer" means any deer without antlers or with an antler less than 3 inches in length.

(1m) "Assisting", for the purpose of bear hunting, means helping a bear harvest permittee hunt a bear by handling dogs, tracking, trailing or locating the bear, or otherwise aiding while with the permittee or baiting.

(2) For the purposes of this chapter, "bait" means honey and any solid or nonliquid material attractive to wildlife.

(3) "Bearded turkey" means a turkey with a bristle-like appendage protruding from the upper part of the breast.

(4) "Bow" means any bow, drawn and held by and through the effort of the person releasing it, but does not include crossbow.

(5) "Buck deer" means any deer with an antler not less than 3 inches in length.

(6) "Crossbow" means any device using a bow which, once drawn, is held solely by means other than the effort of the person firing it.

(7) "Daily bag limit" means the maximum number of a game species which may be reduced to a person's possession in one day.

(8) "Department" means the department of natural resources.

(9) For the purposes of ss. 29.224 (2), 29.56, 29.565 (2), 29.57 (4) and 350.06, Stats., "enclosed within a carrying case" for firearms means completely contained in a gun case expressly made for that purpose which is Register, June, 1986, No. 366

fully enclosed by being zipped, snapped, buckled, tied, or otherwise fastened, with no portion of the firearm exposed.

Note: Subsection (9) does not remove the requirement of ss. 29, 224 and 350.06, Stats., to enclose bows or crossbows in carrying cases. The rule does not apply to bows or crossbows only because the natural resources board recognizes that certain designed bow cases may allow portions of the bow, for instance the handle, to be exposed and yet still render the bow inoperable.

(10) "Firearm season" means an open season for hunting with any of the following firearms loaded with a single slug or ball: rifle, muzzle-loader, shotgun or handgun for deer hunting described in s. NR 10.09 (1) (c) 1, c..

(11) "Goose zones and areas" means those established in s. NR 10.01 (1) (i) through (t).

(13) "Liquid" means a substance, neither solid or gaseous, that flows freely and takes the shape of its container at a temperature of 70°F.

(14) "Liquid scent" means any nonsolid material except honey.

(15) "Migratory game birds" means any bird which is migratory and on which an open season has been prescribed in this chapter and belonging to one of the following families:

(a) Anatidae (wild ducks, geese and brant),

(b) Rallidae (rails, coots and gallinules),

(c) Scolopacidae (woodcock and Wilson's snipe (jacksnipe)).

(16) "Molest" means any activity which results in physical damage or destruction of an object.

(17) For the purpose of hunting deer and bear, "muzzle-loader" means any smoothbore muzzle-loading firearm of not less than .45 caliber and any rifled muzzle-loading firearm of not less than .40 caliber, discharged from the shoulder.

(18) For the purpose of hunting wild animals other than deer and bear, "muzzle-loader" means any caliber of any muzzle-loading firearm discharged from the shoulder.

(19) "Non-toxic shot" means steel shot.

(20) "Open water" means any water beyond a natural growth of vegetation rooted to the bottom and extending above the water surface of such height as to offer whole or partial concealment for the hunter. Dead stumps and dead trees in water do not constitute a natural growth of vegetation.

(21) "Permanent abode" means a person's principal or ordinary home or dwelling place as distinguished from a temporary abode.

(22) "Possession limit" means the maximum number of a game species which may be reduced to a person's possession in 2 days or more.

(23)"Preservation facility" means any permanent abode, cold storage facility, locker plant, taxidermy establishment, hunting club or place of business which receives or possesses any game belonging to another per-Register, June, 1986, No. 366 son for the purposes of picking, cleaning, freezing, processing, storage or shipment.

(24) "Shotgun season" means an open season for hunting with either of the following firearms loaded with a single slug or ball: muzzle-loader or shotgun.

(25) "Sight exposed bait" means any bait which can be seen from above the bait.

(26) "Temporary abode" means a transient place of abode or dwelling such as a hunting club, or any clubhouse, cabin, tent, or trailer used as a hunting club, or any hotel, motel or roominghouse used during a hunting trip.

(27) "Unforked antler" means a polished antler consisting of a single spike without branches or tines.

(28) "Water" in non-toxic shot zones means lakes, ponds, marshes, swamps, rivers, streams, and drainage ditches except for temporary sheet water. All county boundary waters and lakes partially within a non-toxic shot zone are totally included except the open water of Green Bay and Lake Michigan and the Wisconsin river outside Columbia county.

(29) "Water set" means any trap which is set or staked in such a manner as to permit the trap or trapped animal to reach water at any point.

(30) "Waterfowl" means any migratory game bird of the family Anatidae including wild ducks, geese and brant.

3. Exhibition required. Each person who has trapped an otter shall exhibit each pelt to an authorized department representative in the county in which the animal was trapped, or in the adjoining county, but within the area open to otter trapping, no later than 5 days after the close of the otter season.

4. Registration. The department representative shall inspect the pelt, attach and lock a registration tag to the head of all lawfully taken and possessed otter.

5. Possession and transfer restrictions. No person may: a. Take more than a total combined season bag limit of 2 otter.

b. Possess raw otter pelts beginning 6 days after the close of the otter season to the opening date of the following otter season without a registration tag attached to the head of the otter and locked.

c. Transfer, give, trade, sell or purchase any otter pelt without a registration tag being attached and locked to the head of each pelt.

(e) *Recording of fisher and otter.* 1. Tagging and permits. a. No person may trap or attempt to trap any fisher or otter unless having first applied for and received from the department a trapping permit and tag or tags authorizing such trapping.

(

b. Applications for permits and tags shall be received by the department no later than the first Friday in October each year.

c. If the number of applications for fisher permits exceeds the number available in subd. 2, successful applicants shall be determined by random selection.

d. The trapper shall attach the permit to his or her trapping license before trapping any fisher or otter.

e. Each permit shall be numbered to correspond to the applicant's current trapping license and show the applicant's name and tag numbers.

f. No person may apply for more than one fisher permit or one otter permit.

2. Permit quota. The department shall issue the following numbers of permits for the 1985 fisher trapping season:

a. Management zone A - 100.

b. Management zone B - 125.

c. Management zone C - 75.

3. Tagging procedure. a. Each person shall immediately upon possessing a fisher or an otter, attach and lock a valid tag, issued by the department, through the opening of the mouth to the opening of the eye, immediately beneath the skin.

b. No person may have a fisher or an otter pelt in possession or under control unless the person trapping the animal attaches the tag as required by this subdivision.

c. The tag shall remain attached to the pelt until removed by a fur dresser or taxidermist at time of preparation.

4. Fisher exhibition. Unless otherwise authorized by the department, each person who has trapped a fisher shall exhibit the pelt separated from the carcass along with the carcass to an authorized department representative in the management unit in which the animal was trapped, or in an adjoining unit, no later than 5 days after the close of the fisher season. The fisher carcass shall be retained by the department.

5. Otter exhibition. Each person who has trapped an otter shall exhibit each pelt to an authorized department representative in the county in which the animal was trapped, or in an adjoining county, but within the area open to otter trapping, no later than 5 days after the close of the otter season.

6. Registration. The department shall inspect the pelt, attach and lock a registration tag to the head of all lawfully taken and possessed fisher and otter.

7. Possession and transfer restrictions. No person may: a. Possess raw fisher or otter pelts later than 5 days after the close of the fisher and otter seasons to the opening date of the following fisher and otter seasons without a registration tag attached and locked to the head of the animal.

b. Transfer, give, trade, sell or purchase any fisher or otter pelt without a registration tag being attached and locked to the head of the pelt.

barrel length of 5½ inches measured from the muzzle to the firing pin with the action closed. Handguns used for deer hunting are restricted to areas open to a firearm season. Hunters using such handguns may not possess any other gun while hunting deer.

Note: Persons under the age of 18 years, pusuant to s. 941.22, Stats., may not hunt with handguns. Hunters using handguns must comply with all state and federal laws respecting handguns, including s. 941.23, Stats., respecting concealment, and s. 29.224, Stats., respecting transportation. This rule only authorizes hunting deer with handguns in areas open to rifle hunting during the deer gun season.

d. Crossbows may be used by disabled individuals issued a permit under s. 29.104 (4), Stats.

2. Deer or bear hunting. Hunt any deer or bear with any .22 rim-fire rifle, 5 mm rim-fire rifle, .17 caliber center-fire rifle or .410 bore shotgun.

3. Possession. Possess any rifle larger than .22 rim-fire in areas wherein there is an open season for hunting deer with shotgun only unless such rifle is unloaded and enclosed within a carrying case.

(2) SPECIAL ONE-DAY RESTRICTION. During the 24-hour period prior to the opening date for hunting deer with guns, no person shall possess a gun wherein there is an open season for deer with guns unless the gun is unloaded and enclosed within a carrying case. Exceptions:

(a) Target shooting at established ranges.

(b) Hunting on licensed game farms and shooting preserves.

(c) Hunting migratory game birds during the open season.

(3) Bows and arrows. No person may:

(a) Possession of strung bow. Possess a bow while in, on, or traversing areas inhabited by deer during the open season for hunting deer from one-half hour after the close of hunting hours established in s. NR 10.06 (3) to one-half hour before opening of hunting hours unless such bow is unstrung or enclosed within a carrying case.

(b) Special restrictions. Use, possess or have under control while hunting, any poisoned or drugged arrow, arrow with explosive tips or any crossbow.


(c) Arrow standards. Use, possess or have under control while deer or bear hunting, any arrow with a metal broad-head blade less than seveneights of an inch in width. Such broad-head blades must be wellsharpened.

(d) *Bow size*. Hunt deer or bear with a bow having a pull of less than 30 pounds.

NR 10.10 Deer and bear hunting. (1) PROHIBITED METHODS. No person shall hunt deer or bear by any of the following methods:

(b) Dogs. With the aid of dogs, except that dogs may be used for hunting bear during the season established in s. NR 10.01 (3) (g) 2. in that portion of the state north of the highways shown in the following map:



(2) ILLEGAL GAME. Any deer killed during the open season for hunting deer with bow and arrow showing evidence that it was shot with a firearm shall be an illegal game animal and no person may have such animal in possession.

NR 10.101 Bear hunting. (1) PROHIBITED METHODS. No person may:

(a) Denned bear. Hunt or shoot a bear in a den.

(b) Restricted areas. Hunt bear in any dump or sanitary landfill. Register, June, 1986, No. 366

(c) Adult bear with cubs. Shoot, shoot at or kill an adult bear accompanied by a cub or cubs.

(2) DOG PERMIT. (a) Permit requirement. No person may use a dog to hunt bear without being in possession of a bear-dog permit and valid state hunting license.

(b) Permit application procedures. 1. Application forms supplied by the department shall be completed and submitted by the applicant.

2. It shall be unlawful for any person to submit an application containing false information.

(c) Permit issuance procedures. 1. Permits shall be issued only to per-sons possessing a valid Wisconsin hunting license.

2. Permits are not transferable and shall not be altered or defaced.

3. Permits are valid only during the season of issuance.

4. Duplicate permits may be issued to replace lost or destroyed permits.

(3) DOG USE RESTRICTIONS. (a) Identification. No person shall hunt or pursue bear with any dog unless such dog is tattooed or wears a collar with the owner's name and address attached.

(b) Training. The training of dogs by pursuing wild bear is prohibited except July 10 through August 31.

Note: Bear dog trials and training are regulated by ch. NR 17.

(c) Pack size. No more than 6 dogs in a single pack may be used to pursue bear regardless of the number of bear hunters assisting the bear harvest permittee and regardless of the dog ownership.

Note: Only a bear hunting licensee with a bear harvest permittee may pursue bear during the open season on bear.

(d) Dog replacement. Until the maximum of 6 dogs are released in pursuit of a bear, dogs may be added to the pack. However, no dogs engaged in the pursuit of such bear may be replaced by another dog.

(e) Bail use. Persons hunting bear with dogs may use bait in accordance with s. NR 10.07 (1) (g) during the season established in s. NR 10.01 (3) (g) 2.

Note: This rule does not permit a person to hunt bear over bait without using dogs as a hunting aid.

(4) BEAR CARCASS TAGS. (a) Validation. Any person killing a bear shall immediately validate the carcass tag by slitting the mark designating the month, day, time of kill and bear sex.

(b) Attachment. Immediately following validation, the carcass tag shall be attached to the bear at any location on the bear.

(c) Removal and retention. A bear carcass tag attached under par. (b) and department registration tag may be removed from a gutted carcass at the time of butchering or when prepared by a licensed taxidermist, but

the person who killed or obtained the bear shall retain all tags until the meat is consumed.

NR 10.102 Bear hunting permits. (1) HARVEST LEVEL AND PERMIT STAN-DARDS. (a) Permit quota. The department shall issue 860 bear harvest permits for the 1986 bear season.

(b) Application procedure. Application for harvest permits shall be on forms provided by the department. They shall be postmarked no later than the Friday nearest July 10 or received by the department license section, 101 South Webster, P.O. Box 7924, Madison, WI 53707 no later than 4:30 p.m. on that date of each year.

(c) Permit issuance. The department shall select successful applicants and issue permit approval notices no later than August 10 of each year. The department may reissue permits which are returned undelivered by the postal authorities or the applicant fails to or cannot comply with s. 29.1085, Stats. Selection shall be by random drawing.

(d) Fees. A successful applicant shall submit the permit fee to the department before receiving a harvest permit. The fees shall be mailed and postmarked no later than August 25 or received by the department license section, 101 South Webster, P.O. Box 7924, Madison, WI 53707 no later than 4:30 p.m. on that date of each year.

(e) *Permit attachment*. The bear harvest permit shall be attached to the bear hunting license by the applicant immediately upon receipt.

(2) BEAR PURSUIT. No licensee may pursue a bear by any method unless that person holds a valid bear harvest permit or is assisting a person who holds a valid bear harvest permit issued under s. 29,1085, Stats.

NR 10.103 Deer hunting. (1) TAGS. A one-piece back and carcass tag shall be issued with each hunting license and shall remain intact until the hunter kills a deer.

(2) VALIDATION. Any person who kills a deer shall immediately separate the issued carcass tag from the back tag and validate the carcass tag by slitting the mark designating the month, day, time of kill and type of deer. Failure to completely validate the carcass tag renders possession of the deer illegal and the carcass tag invalid.

NR 10.104 Deer hunting permits. (1) FINDING. The natural resources board finds that an additional harvest of deer is necessary to reduce the deer herd to the overwinter population goals established in s. NR 10.01 (3) (e) 9. e. and properly manage the deer herd in the state.

(2) APPLICATION PROCEDURE. Permits shall be in accordance with ss. 29.107 and 29.108, Stats., issued to any person in possession of a valid current Wisconsin deer hunting license applying in the following manner:

(a) Limit. No person may submit more than one application.

(b) Form. Application forms supplied by the department shall be completed and submitted by the applicant.

(c) *Deadline*. Applications shall be postmarked no later than the first Friday in October.

(3) PERMIT ISSUANCE. Upon receipt of proper application, the department shall issue permits in the following manner:

(a) Initial permit. Successful applicants for hunter's choice or antlerless permits shall be determined by random selection from all eligible applications received for each deer management unit. Permits remaining unissued for any deer management unit after all initial applications have been processed may be issued by the department on a first-come, firstserved basis, in accordance with any statutorily established landowner preference permit issuance system, or as established by par. (b).

(b) Second permit. If the number of hunters choice or antlerless permits in any management unit exceeds the number of applications for such permits, the department may issue the remaining permits available for that unit as antlerless deer hunting permits only to its successful initial deer hunting permit applicants. Permittees to be issued the second permit shall be randomly selected in accordance with any statutorily established landowner preference permit issuance system.

(4) PERMIT VALIDATION. Validation decals numbered to correspond with the permit shall be issued to each successful applicant. The permit holder shall affix a validation decal to his or her current deer registation stub and corresponding back tag immediately upon receipt.

(5) PERMIT AUTHORITY. No person may hunt anterless deer in deer management units described as such in s. NR 10.01 (3) (e) unless he or she possesses a current validated deer hunting permit.

(6) BAG LIMIT. Each issued deer hunting permit shall authorize the use of the holder's current valid Wisconsin deer hunting license, back tag and carcass tag for the killing of one deer in the deer management unit designated on the permit as follows:

(a) Hunter's choice deer hunting permit - Valid for the taking of one deer of either sex or age, except on Chambers Island in Door County where the bag limit shall be one antlerless deer or one buck deer with a forked antler as indicated on the permit.

(b) Antlerless deer hunting permit - Valid for the taking of one antlerless deer only.

NR 10.105 Transportation of deer and bear. No person may transport any deer or bear in or on any motor-driven vehicle from the time such deer or bear is killed to the time it is lawfully registered pursuant to s. NR 10.106 unless the deer or bear is carried openly exposed and in such a manner so that the deer or bear tag attached to the deer or bear cannot be handled or manipulated by any occupant of the vehicle.

NR 10.106 Recording deer and bear. (1) CARCASS CONDITION AND TRANSPORTATION. Deer and bear shall be intact except they may be field dressed. These animals or animal parts may not be removed from the area specified in this section unless exhibited, registered and tagged.

(2) EXHIBITION AND REGISTRATION. Each person who has killed a deer during the open seasons for hunting deer with guns or bear during the open seasons for hunting bear with guns or bows shall exhibit and register the deer with the deer carcass tag attached as required by s. 29.40 (1), Stats., and s. NR 10.103, or the bear with the bear carcass tag attached as required by ss. 29.1085 (5), Stats., and s. NR 10.101(4) at an authorized registration station as follows:

(a) Gun license deer. Gun license deer shall be registered within the open season zone in which the deer was killed no later than 5:00 p.m. of the first day following the season's close.

(b) Special permit deer. Party permit deer or antlerless deer taken under the authority of a hunter's choice permit shall be registered within the deer management unit in which the deer was killed no later than 5:00 p.m. of the first day following the season's close unless transported on federal or state highways directly to the authorized registration station in an adjoining deer management unit.

(c) Lake Superior islands deer. Any gun killed deer taken on any of the islands in the outlying waters of Lake Superior in Ashland and Bayfield counties shall be registered within the deer management unit in which the deer was killed or within the city of Bayfield no later than 5:00 p.m. of the first day following the close of such season.

(d) Archer license deer. Archer license deer shall be registered within the county in which the deer was killed or adjoining county no later than 5:00 p.m. of the day after it was killed.

(e) Bear license (bow and gun). Bear shall be registered within the county in which the bear was killed or adjoining county no later than 5:00 p.m. of the day after it was killed.

(3) REGISTRATION TAGGING. (a) Bear. Upon verification of license information, the station operator shall lock a registration tag to the bear or bear part.

(b) Deer. For deer, the operator shall:

 ${\bf 1}.$ Complete and retain the registration portion of the hunter's license; and

2. Lock a registration tag to the deer or deer part.

3. Remove the validation portion of the carcass tag.

NR 10.117 Deer season modification. (1) POWERS. The secretary of the department may, upon making the findings in sub. (2), extend the gun deer season for any deer management unit or any group of deer management units to reduce or maintain the deer population to the overwinter population goals established in s. NR 10.01 (3) (e) 9. e.

(2) FINDING. The secretary shall, prior to exercising powers under sub. (1), find:

(a) It is unlikely the deer population for the deer management unit will be reduced to or maintained at the overwinter population goals established in s. NR 10.01 (3) (e) 9. e. during the established gun deer season. A minimum of 2 days of the gun deer season have been completed and the harvest data available has been reviewed and considered by the department;

(b) It is likely that a failure to reduce the deer population to the overwinter population goals in the unit will result in increased deer damage to commercial seedings or crops on agricultural lands, nurseries or orchards or a waste of the resource.

(3) NOTICE. Modification by the secretary under sub. (1) shall become effective upon issuance of an order and publication in the official state newspaper. In addition, a copy of the order shall be provided to newspapers in the area affected and to all legislators.

NR 10.12 Migratory game bird hunting. (1) PROHIBITED METHODS. No person shall hunt any migratory game bird by any of the following methods:

(a) *Sinkbox*. From or by means, aid or use of a sinkbox or any other type of low floating device, having a depression affording the hunter a means of concealment beneath the surface of the water.

(b) *Boais*. From any boat or craft other than those propelled by paddle, oar or pole. When motors or sails are attached to the boat, the motor shall be completely shut off and the sail furled, and the boat's progress stopped before a firearm may be loaded.

(c) Structures. From any pier, dam, dock or similar structure.

(d) *Rallying*. By the use or aid of any water, air or motor-driven land conveyance used for the purpose of or resulting in stirring up, driving or rallying.
