(b) Necedah. Township 18 north, range 3 east, town of Necedah.






(b) Peat Lake. Township 1 north, range 20 east, town of Salem.









(7) RACINE COUNTY. (a) Dover. Township 3 north, range 20 east, town of Dover.




(b) Tichigan wildlife area. Township 4 north, range 19 east, town of Waterford.






(9) VILAS COUNTY. (a) Powell Marsh. Township 42 north, range 5 east, town of Manitowish Waters.









(1) MARATHON COUNTY. (a) Beans Eddy. Township 26 north, range 6 east, town of Bergen.



(b)  $\mathit{Berkhahn}$  Flowage. Township 26 north, range 6 east, town of Bergen.








(d) McMillan Marsh. Township 26 north, range 2 east, town of Spencer and township 26 north, range 3 east, town of McMillan.




(e) Mead. Township 26 north, range 5 east, town of Green Valley.






