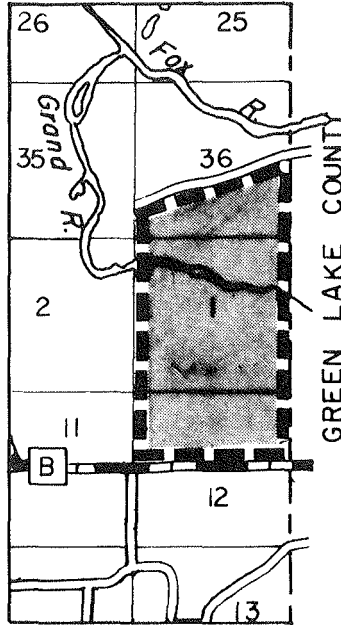
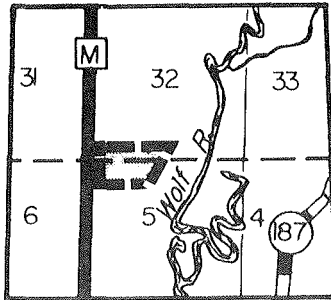

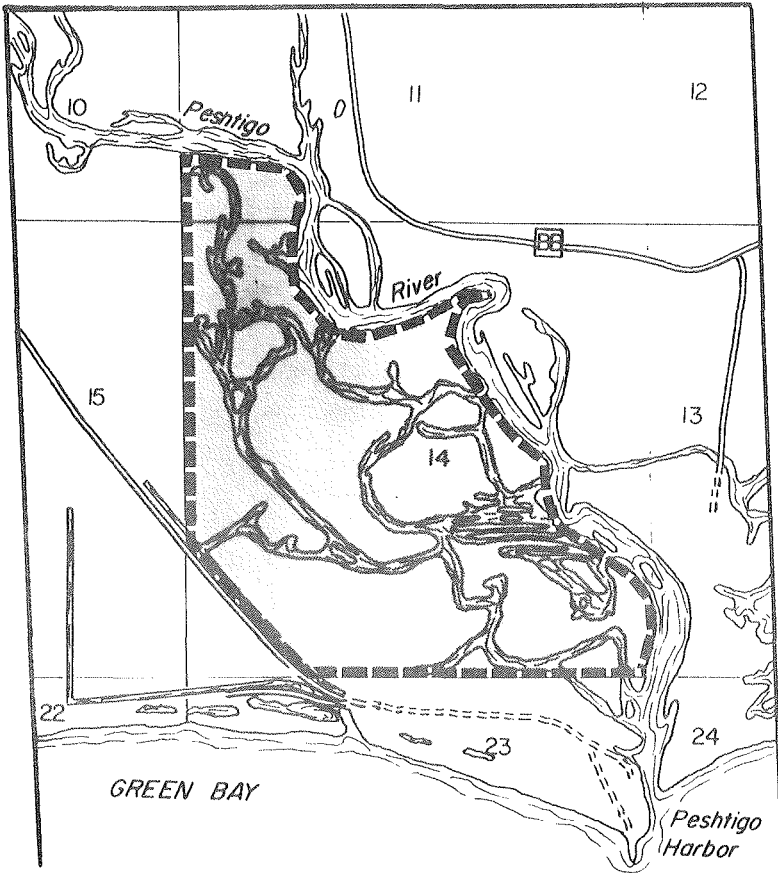
(8) OUTAGAMIE COUNTY. (a) *Outagamie wildlife area*. Township 23 north, range 16 east, town of Bovina.



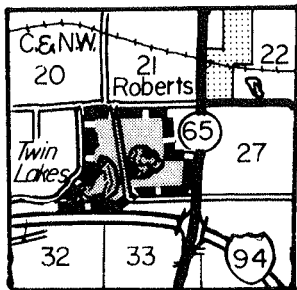
