Cos 9.01 License renewal. To renew a license a licensee shall, on or before March 31 of every odd–numbered year, file with the department all of the following:

(1) An application for renewal on a form prescribed by the department.

(2) The fee determined by the department under s. 440.03 (9) (a), Stats.

(3) Certification on the application for renewal that the licensee has, during the biennial reporting period immediately preceding application, completed the continuing education requirements in s. Cos 11.03.
