**PSC 8.01 Forms.** The forms named in this chapter are listed according to title, as provided for in section 227.013 (3), Wis. Stats., with such explanatory material as is additionally required for identification being given in editorial brackets.

**PSC 8.02 Obtaining forms.** Forms listed in this chapter may be obtained from the Public Service Commission, State Office Building, Madison, Wisconsin, to the extent necessary to enable the utilities, motor carriers, and railroads to submit information in compliance with the statutes and commission rules. In certain instances a nominal charge may be made for forms supplied to persons who are not required to file data as therein specified. Inquiries on obtaining forms should be addressed to the commission as shown above.

**PSC 8.05 Motor carrier forms.** (1) APPLICATIONS. (a) Application for common motor carrier certificate.

(b) Application for amendment to common motor carrier certificate.

(c) Application for approval of assignment of license or certificate.

(d) Application for contract motor carrier license.

(e) Application for amendment to contract motor carrier license.

(2) REPORTS. (a) Motor carrier annual report form A, class I motor carriers of property or passengers. [This is an interstate commerce commission form applicable to class A carriers in Wisconsin.] For additional Wisconsin data, there are two insert pages: 53a—operating revenues—Wisconsin statement (property carriers) and 71a—operating statistics—property carriers—Wisconsin.

(b) Annual report of common motor carrier [other than class A.]

(c) Quarterly report of revenues, expenses, and statistics, class I motor carriers of property. [This is an interstate commerce commission form applicable to class A motor carriers of property in Wisconsin.]

(d) Quarterly report of revenues, expenses, and statistics, class A common motor carriers of passengers.

(e) Monthly report of bus transportation.

**PSC 8.06 Railroad reports.** (1) ACCOUNTS AND OPERATION. (a) Steam railway state commission form A—steam—annual report [a form printed by the interstate commerce commission] and insert page 700A—income account for the year—Wisconsin.

(b) Quarterly report by months of revenues, expenses and railway investment [required of class I steam railroads].

(c) Gross operating revenues derived from intrastate operations in the state of Wisconsin for calendar year 19\_\_\_\_. [Required of railroads as defined in section 195.02, Wis. Stats.]

(d) Statement of highway crossing changes to public service commission.

(2) ACCIDENT REPORTS. (a) Monthly report of accidents on electric railways.

(b) Monthly report of railway accidents.

(c) Monthly report of railway accidents [summary of separate reports made in (b) above].

(d) Monthly report of railway accidents—subsequent fatalities.

PSC 8.07 Utility reports. (1) Annual financial report of class A [utility].

(2) Annual report of class B [utility], financial section.

(3) Annual operating report, electric utility, class A.

(4) Electric operating section, class B [utility], of annual report.

(5) Annual report of electric, water, or joint utility, class C or D.

(6) (a) Annual statement of electric, water, or joint utility (utilities smaller than class D).

(b) Insert page 4a—water plant.

(7) Annual operating report, water utility, class A.

(8) Water operating section, class B [utility], of annual report.

(9) Report of sewer utility [annual].

(10) Annual operating report, gas utility, class A.

(11) Gas operating section, class B [utility], of annual report.

(12) Annual report of telephone utility, classes A & B.

(13) Annual report of telephone utility, class C.

(14) Annual report of telephone utility, class D.

(15) Annual report of telephone utility, for telephone utilities having less than \$3,000 annual revenues, excluding roadway companies.

(16) TELEPHONE EXCHANGE REPORT. (a) Operating income statement.

(b) Operating expenses except taxes.

(c) Telephone plant in service at end of year.

(d) Station and line data—end of year.

(e) Outside plant data—end of year.

(17) Telephone rate file.

(18) Report year ended December 31, 19\_\_ [required of roadway telephone companies].

(19) Annual report of heating utility.

(20) Data to supplement information contained in annual report [a form sent to those utilities having operations in Wisconsin and some other state or states and whose annual report form does not include Wisconsin intrastate and out-of-state operational data necessary to computation of remainder assessments].

(21) Annual operating report, electric railway.

**PSC 8.10 Water powers; application forms.** (1) Application for approval of the placing of sand or other similar material on bed of lake. (section 30.02 (1) (ba), Wis. Stats.)

(2) Application for permit to divert water for irrigation under section 31.14, Wis. Stats.

(3) Application for contract to dredge materials from beds of navigable lakes listing those facts which are necessary before the commission can determine that the application meets the requirements of section 31.02 (5), Wis. Stats.

(4) Application for a permit to construct, operate, and maintain a dam in a navigable stream. (sections 31.05, 31.06, 31.09 and 31.12, Wis. Stats.)

(5) Application for permit to abandon a dam—31.185; Wis. Stats.
