



**SENATE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 389**

March 5, 1996 – Offered by COMMITTEE ON HEALTH, HUMAN SERVICES AND AGING.

1 At the locations indicated, amend the bill, as shown by assembly substitute
2 amendment 2, as follows:

3 **1.** Page 4, line 13: delete “(m)” and substitute “(m), (mt), (mx), (mz)”.

4 **2.** Page 6, line 16: after that line insert:

5 “(mt) 1. A person practicing music therapy, if all of the following apply:

6 a. The person is certified or accredited as a music therapist by the Certification
7 Board for Music Therapists or by another national organization that certifies or
8 accredits music therapists.

9 b. The organization that certified or accredited the person under subd. 1. a. is
10 approved by the examining board.

11 c. The person files with the examining board evidence satisfactory to the
12 examining board that he or she is certified or accredited as required under subd. 1.

13 a.

14 2. Subdivision 1. does not apply after October 1, 1999.

15 (mx) 1. A person practicing art therapy, if all of the following apply:

1 a. The person is certified or accredited as an art therapist by the Art Therapy
2 Credentials Board or by another national organization that certifies or accredits art
3 therapists.

4 b. The organization that certified or accredited the person under subd. 1. a. is
5 approved by the examining board.

6 c. The person files with the examining board evidence satisfactory to the
7 examining board that he or she is certified or accredited as required under subd. 1.
8 a.

9 2. Subdivision 1. does not apply after October 1, 1999.

10 (mz) 1. A person practicing dance therapy, if all of the following apply:

11 a. The person is registered or accredited as a dance therapist by the American
12 Dance Therapy Association or by another national organization that registers or
13 accredits dance therapists.

14 b. The organization that registered or accredited the person under subd. 1. a.
15 is approved by the examining board.

16 c. The person files with the examining board evidence satisfactory to the
17 examining board that he or she is registered or accredited as required under subd.
18 1. a.

19 2. Subdivision 1. does not apply after October 1, 1999.”.

20 **3.** Page 8, line 24: after that line insert:

21 “**SECTION 18m. Effective dates.** This act takes effect on the day after
22 publication, except as follows:

1 (1) The treatment of section 455.02 (title), (1) (a) and (b), (1m), (2), (2m) (intro.),
2 (a), (b), (c), (e), (g), (h), (i), (k), (L), (m), (mt), (mx), (mz) and (n) and (3) (a) (intro.), 1.
3 and 2. and (b) of the statutes takes effect on October 1, 1996.”
