



**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 706**

February 5, 1996 – Offered by Representative MUSSER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 5, line 13: after “period” insert: “after completing service on active
3 duty and”.

4 **2.** Page 7, line 16: after “period” insert: “after completing service on active
5 duty and”.

6 **3.** Page 11, line 25: delete “15 consecutive years” and substitute: “5
7 consecutive years after completing service on active duty”.

8 **4.** Page 12, line 24: after “period” insert: “after completing service on active
9 duty and”.

10 **5.** Page 15, line 11: after “resident who” insert: “is a veteran, as defined in s.
11 45.35 (5) (a) or who”.

12 **6.** Page 15, line 13: after “armed forces” insert “for 2 consecutive years”.

13 **7.** Page 16, line 5: after “residents who” insert: “are veterans, as defined in s.
14 45.35 (5) (a) or who”.

1 **8.** Page 16, line 7: delete the stricken material and substitute: “for 2
2 consecutive years, except service”.

3 **9.** Page 16, line 8: delete “~~on active duty for training purposes~~” and substitute:
4 “on active duty for training purposes”.

5 **10.** Page 16, line 17: after that line insert:

6 “**SECTION 31m.** 45.43 (8) of the statutes is created to read:

7 45.43 **(8)** QUALIFICATIONS APPLICATION. The qualifications necessary to be a
8 county veterans’ service officer or assistant county veterans’ service officer under
9 subs. (1) (a) and (6) (b) apply only to persons elected to serve as county veterans’
10 service officers or assistant county veterans’ service officers on or after the effective
11 date of this subsection [revisor inserts date], who have not served as county
12 veterans’ service officers or assistant county veterans’ service officers before the
13 effective date of this subsection [revisor inserts date].”.

14 **11.** Page 17, line 14: after “period” insert: “after completing service on active
15 duty and”.

16 **12.** Page 20, line 4: after that line insert:

17 “**SECTION 41g.** 230.03 (14) (a) (intro.) of the statutes is amended to read:

18 230.03 **(14)** (a) (intro.) A person who served on active duty under ~~honorable~~
19 conditions other than dishonorable in the U.S. armed forces and who was entitled to
20 receive any of the following:

21 **SECTION 41m.** 230.03 (14) (b) of the statutes is amended to read:

22 230.03 **(14)** (b) A person who served on active duty under ~~honorable~~ conditions
23 other than dishonorable in the U.S. armed forces in Grenada, Lebanon, Panama,
24 Somalia or a Middle East crisis under s. 45.34.”.
