



**SENATE AMENDMENT 1,
TO 1995 SENATE BILL 460**

March 5, 1996 – Offered by COMMITTEE ON HEALTH, HUMAN SERVICES AND AGING.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: delete that line and substitute:

3 “**SECTION 1m.** 48.981 (7) (a) 2m. of the statutes is created to read:

4 48.981 (7) (a) 2m. A person authorized to provide or providing intake or
5 dispositional services for the court under s. 48.067, 48.069 or 48.10.

6 **SECTION 1p.** 48.981 (7) (a) 2r. of the statutes is created to read:

7 48.981 (7) (a) 2r. A person authorized to provide or providing intake or
8 dispositional services under s. 938.067, 938.069 or 938.10.

9 **SECTION 1r.** 48.981 (7) (a) 7. of the statutes is repealed.”.

10 **2.** Page 2, line 4: after that line insert:

11 “**SECTION 2d.** 48.981 (7) (a) 10. of the statutes is amended to read:

12 48.981 (7) (a) 10. A court conducting proceedings under s. 48.21, a court
13 conducting proceedings related to a petition under s. 48.13 or 48.42 or a court
14 conducting dispositional proceedings under subch. VI or VIII in which abuse or
15 neglect of the child who is the subject of the report or record is an issue.

16 **SECTION 2m.** 48.981 (7) (a) 10g. of the statutes is amended to read:

1 48.981 (7) (a) 10g. A court conducting proceedings under s. 48.21, a court
2 conducting proceedings related to a petition under s. 48.13 (3m) or (10m) or a court
3 conducting dispositional proceedings under subch. VI in which an issue is the
4 substantial risk of abuse or neglect of a child who, during the time period covered by
5 the report or record, was in the home of the child who is the subject of the report or
6 record.

7 **SECTION 2r.** 48.981 (7) (a) 10j. of the statutes is created to read:

8 48.981 (7) (a) 10j. A court conducting proceedings under s. 938.21, a court
9 conducting proceedings relating to a petition under ch. 938 or a court conducting
10 dispositional proceedings under subch. VI of ch. 938 in which abuse or neglect of the
11 child who is the subject of the report or record is an issue.

12 **SECTION 2v.** 48.981 (7) (a) 11. of the statutes is amended to read:

13 48.981 (7) (a) 11. The county corporation counsel or district attorney
14 representing the interests of the public and the counsel or guardian ad litem
15 representing the interests of a child in proceedings under subd. 10. ~~or~~ 10g or 10j.”.

16 **3.** Page 3, line 8: after that line insert:

17 “**SECTION 7m. Effective dates.** This act takes effect on the day after
18 publication, except as follows:

19 (1) The treatment of section 48.981 (7) (a) 2r., 10j. and 11. of the statutes takes
20 effect on July 1, 1996, or on the day after publication, whichever is later.”.
