



**ASSEMBLY AMENDMENT 5,
TO ASSEMBLY SUBSTITUTE AMENDMENT 2,
TO 1997 ASSEMBLY BILL 651**

March 18, 1998 - Offered by Representatives LAZICH and SCHNEIDER.

19 under s. 59.53 (5) may not initiate any administrative support enforcement
20 proceeding under this subchapter with respect to a person who owes support unless
21 the department or county child support agency first petitions the court with
22 jurisdiction over the matter and the court makes a finding that the person who owes

1 support is delinquent in the payment of support in an amount that is equal to at least
2 100% of the amount of support owed by the person in one month.”.
