**ASSEMBLY AMENDMENT 2,
TO SENATE AMENDMENT 1,
TO 1997 ASSEMBLY BILL 736**

April 28, 1998 – Offered by Representative SCHNEIDER.

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 1, line 5: after that line insert:

8 **SECTION 13f.** 29.09 (11m) (c) and (d) 2. of the statutes, as created by 1997
9 Wisconsin Act (Senate Bill 494), are repealed.”.

10 4m. Page 13, line 8: before that line insert:

11 **“SECTION 33g.** 29.138 (5m) (b) of the statutes, as created by 1997 Wisconsin Act
12 (Senate Bill 494), is repealed.

1 **SECTION 33m.** 29.138 (5m) (c) of the statutes, as created by 1997 Wisconsin Act
2 (Senate Bill 494), is amended to read:

3 29.138 **(5m)** (c) The band is requested to enact tribal laws or ordinances that
4 deny an application to issue or renew, suspend if already issued or otherwise
5 withhold or restrict an approval issued under this section if the applicant for or the
6 holder of the approval ~~fails to provide the information required under tribal laws or~~
7 ~~ordinances enacted under par. (b) or~~ fails to comply, after appropriate notice, with a
8 subpoena or warrant issued by the department of workforce development or a county
9 child support agency under s. 59.53 (5) and related to paternity or child support
10 proceedings or if the department of workforce development certifies that the
11 applicant for or the holder of the approval has failed to pay court-ordered payments
12 of child or family support, maintenance, birth expenses, medical expenses or other
13 expenses related to the support of a child or former spouse.”.

15 **“SECTION 43m.** 1997 Wisconsin Act (Senate Bill 494), Section 9336 (1) and
16 (2) are amended to read:

17 [1997 Wisconsin Act (Senate Bill 494)] Section 9336 (1) APPROVAL DENIALS
18 FOR SUPPORT DELINQUENCY. The treatment of sections 29.09 (11m), 29.1085 (3) (c) 1.
19 and 2., 29.134 (3), 29.135 (3), 29.145 (1c) (intro.), 29.33 (2) (d), 29.521 (2) (a) and (c)
20 1., 29.544 (3), 29.574 (3), 29.575 (3) and 29.578 (4), (5) and (14) (am) and (b) (intro.)
21 of the statutes (~~with respect to information required on applications and with respect~~

7 received on the effective date of this subsection and (with respect to denial of or
8 refusal to renew a license, registration or certification for failure to comply with a
9 subpoena or warrant) first applies to failures to comply with subpoenas or warrants
10 that are issued on the effective date of this subsection.”.”.
