**ASSEMBLY AMENDMENT 21,  
TO ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO ASSEMBLY BILL 1**

March 14, 2002 – Offered by Representative KRUG.

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 4, line 4: after that line insert:

3 “1m. Page 5, line 4: after that line insert:

4 “**SECTION 6bg.** 13.08 (2) of the statutes is amended to read:

5 13.08 (2) ~~All members~~ Each member of the legislature shall be entitled to an  
6 allowance for transportation expenses that the member directly incurred in going to  
7 and returning from the state capitol once every week during any legislative session,  
8 at the same rate per mile for each mile traveled in going to and returning from the  
9 state capitol on the most usual route as is provided for transportation for state  
10 officers and employees under s. 20.916. A member may not claim an allowance for  
11 expenses directly incurred by any other person. Such allowances shall be paid

1 monthly upon presentation to the department of administration of a verified written  
2 statement containing such information as the department requires.

3 **SECTION 6br.** 13.123 (1) (a) 1. of the statutes, as affected by 2001 Wisconsin Act  
4 16, is amended to read:

5 13.123 (1) (a) 1. Any member of the legislature who has signified, by affidavit  
6 filed with the department of administration, the necessity of establishing a  
7 temporary residence at the state capital for the period of any regular or special  
8 legislative session shall be entitled to an allowance for expenses incurred for food and  
9 lodging for each day that he or she is in Madison on legislative business, but not  
10 including any Saturday or Sunday unless the legislator is in actual attendance on  
11 such day at a session of the legislature or a meeting of a standing committee of which  
12 the legislator is a member. The amount of the allowance for each biennial session  
13 shall be 90% of the per diem rate for travel for federal government business within  
14 the city of Madison, as established by the federal general services administration.  
15 A member who spends less than 4 hours in Madison on a Tuesday, Wednesday, or  
16 Thursday may not claim an allowance for that day. A member may not use a different  
17 certification system than is used by employees of the legislature. A member who does  
18 not use a hotel or apartment in Madison may only claim the allowance rate under  
19 subd. 2. Members shall submit annual proof to the chief clerk for each day that they  
20 claim an allowance. For the purpose of determining the amount of the allowance, the  
21 secretary of employment relations shall certify to the chief clerk of each house the  
22 federal per diem rate in effect on December 1, or the first business day thereafter if  
23 December 1 is not a business day, in each even-numbered year. Each legislator shall  
24 file an affidavit with the chief clerk of his or her house certifying the specific dollar

1 amount within the authorized allowance the member wishes to receive. Such  
2 affidavit, when filed, shall remain in effect for the biennial session.”.”.

3 **2.** Page 4, line 9: after that line insert:

4 “2m. Page 5, line 4: after that line insert:

5 “**SECTION 6k.** 13.20 (4) of the statutes is created to read:

6 13.20 (4) A member who has ever had a legislative employee who is assigned  
7 to the member go door-to-door during regular business hours in the member’s  
8 assembly or senate district shall reimburse the chief clerk for that time spent by the  
9 employee.”.”.
