



**ASSEMBLY AMENDMENT 55,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2001 SENATE BILL 55**

June 29, 2001 – Offered by Representative BLACK.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 137, line 15: after that line insert:

3 “(fL) Distribution of U.S. flag and

4 patriotic documents GPR S -0- -0-”.

5 **2.** Page 317, line 18: after that line insert:

6 “**SECTION 558m.** 20.255 (2) (fL) of the statutes is created to read:

7 20.255 (2) (fL) *Distribution of U.S. flag and patriotic documents.* A sum
8 sufficient equal to the difference between the amount that the assembly committee
9 on organization authorized to be expended for legal and consulting services, other
10 than for those performed by employees of the Wisconsin legislature in the
11 performance of their regular job responsibilities, to assist the legislature, its

1 committees, and its members in the redistricting of congressional and legislative
2 districts, less \$520,000, to pay for the costs of the distributions under s. 118.06 (4).”.

3 **3.** Page 917, line 22: after that line insert:

4 “**SECTION 2675d.** 118.06 (title) of the statutes is amended to read:

5 **118.06** (title) **Flag and, pledge of allegiance, and declaration of**
6 **independence.**

7 **SECTION 2675g.** 118.06 (4) of the statutes is created to read:

8 118.06 (4) The state superintendent shall distribute to each school district one
9 U.S. flag for each classroom in which the school district does not have a U.S. flag to
10 display on the effective date of this subsection [revisor inserts date], and shall
11 distribute to each pupil in each school district a copy of the pledge of allegiance and
12 a copy of the declaration of independence. The cost of the distributions shall be paid
13 from the appropriation account under s. 20.255 (2) (fL). If the amount in the
14 appropriation account under s. 20.255 (2) (fL) is insufficient to fund fully the cost of
15 the distributions under this subsection, the state superintendent shall prorate the
16 distributions.”.

17 **4.** Page 1343, line 11: after that line insert:

18 “(4xx) RESTRICTION ON EXPENDITURES FOR LEGAL AND CONSULTING FEES FOR
19 REDISTRICTING.

20 (a) Notwithstanding section 20.001 (3) (d) of the statutes, of the amounts
21 appropriated to the assembly under section 20.765 (1) (a) of the statutes in the
22 2001-03 fiscal biennium, no more than \$260,000 may be expended for legal and
23 consulting services, other than for those performed by employees of the Wisconsin
24 legislature in the performance of their regular job responsibilities, to assist the

1 legislature, its committees, and its members in the redistricting of congressional and
2 legislative districts. The limit may be exceeded by an amount approved by all of the
3 members of the committee on assembly organization.

4 (b) Notwithstanding section 20.001 (3) (d) of the statutes, of the amounts
5 appropriated to the senate under section 20.765 (1) (b) of the statutes in the 2001-03
6 fiscal biennium, no more than \$260,000 may be expended for legal and consulting
7 services, other than for those performed by employees of the Wisconsin legislature
8 in the performance of their regular job responsibilities, to assist the legislature, its
9 committees, and its members in the redistricting of congressional and legislative
10 districts. The limit may be exceeded by an amount approved by all of the members
11 of the committee on senate organization.”.
