



**ASSEMBLY AMENDMENT 6,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2003 ASSEMBLY BILL 67**

May 29, 2003 – Offered by Representatives STASKUNAS and HUBER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 3, line 21: before the period insert “, except for an act performed in
3 following a do-not-resuscitate order under s. 154.19 (3)”.

4 **2.** Page 3, line 22: before that line insert:

5 “**SECTION 3g.** 111.337 (2) (c) of the statutes is created to read:

6 111.337 (2) (c) To require an employee who is a physician to make a good faith
7 attempt to transfer a patient to another physician who will comply with a
8 declaration, as defined in s. 154.02 (1), instrument for power of attorney for health
9 care, as defined in s. 155.01 (10), or health care decision, as defined in s. 155.01 (5),
10 of a health care agent, as defined in s. 155.01 (4).”.

11 **3.** Page 5, line 18: delete lines 18 and 19 and substitute “~~procedure or removing~~
12 ~~a human embryo or fetus.~~ A any of the following:”

1 **(b)** Except as provided in sub. (4m), a physician or any other person who is a
2 member of or associated with the”.

3 **4.** Page 6, line 1: delete “(c) A physician” and substitute “(c) Except as
4 provided in sub. (4m), a physician”.

5 **5.** Page 7, line 15: before the period insert “, except for an act performed in
6 following a do-not-resuscitate order under s. 154.19 (3)”.

7 **6.** Page 7, line 17: delete “~~No~~ A hospital” and substitute “~~No~~ Except as
8 provided in sub. (4m), a hospital”.

9 **7.** Page 7, line 23: delete “No hospital” and substitute “~~No~~ Except as provided
10 in sub. (4m), no hospital”.

11 **8.** Page 8, line 23: after that line insert:

12 “**SECTION 14m.** 253.09 (4m) of the statutes is created to read:

13 253.09 **(4m)** Subsections (1r) (b) and (c), (2), and (3) do not apply to the refusal,
14 or the statement of an intention to refuse, of a physician to make a good faith attempt
15 to transfer a patient to another physician who will comply with a declaration, as
16 defined in s. 154.02 (1), instrument for power of attorney for health care, as defined
17 in s. 155.01 (10), or health care decision, as defined in s. 155.01 (5), of a health care
18 agent, as defined in s. 155.01 (4).”.

19 **9.** Page 11, line 4: before the period insert “, except for an act performed in
20 following a do-not-resuscitate order under s. 154.19 (3)”.

21 **10.** Page 11, line 23: delete the material beginning with that line and ending
22 with page 14, line 18.
