Section 2. 14.035 of the statutes is repealed.

2	230.08 (2) (xe), 565.01 (6m) (c) and 569.03 (2); and <i>to create</i> 13.0995 of the
3	statutes; relating to: approval of Indian gaming compacts.
	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
4	Section 1. 13.0995 of the statutes is created to read:
5	13.0995 Approval of Indian gaming compacts. The president of the senate
6	and the speaker of the assembly shall jointly negotiate any compact under $25~\mathrm{USC}$
7	2710 (d). The president and speaker may enter into, amend, extend, or renew a
8	compact on behalf of the state if both the president and the speaker approve the
9	proposed compact and a majority of the members elected to each house of the
10	legislature approves the proposed compact.

Section 3. 20.923 (6) (aL) of the statutes is amended to read:

AN ACT to repeal 14.035 and 569.015 (2); to amend 20.923 (6) (aL), 165.25 (3r),

3	Section 4. 165.25 (3r) of the statutes is amended to read:
4	165.25 (3r) Avoid conflict of interest. Require that attorneys in different
5	organizational subunits in the department prosecute violations of chs. 562 to 569 or
6	Indian gaming compacts entered into under s. 14.035 13.0995 and defend any
7	department, agency, official, employee or agent under subs. (1), (4) (a) and (6).
8	Section 5. 230.08 (2) (xe) of the statutes is amended to read:
9	230.08 (2) (xe) The director of Indian gaming in the department of
10	administration, and the attorney in the department of administration, appointed
11	under s. 569.015 (2).
12	Section 6. 565.01 (6m) (c) of the statutes is amended to read:
13	565.01 (6m) (c) This subsection shall not affect the provisions of any Indian
14	gaming compact entered into before January 1, 1993, under s. 14.035, 2001 stats.
15	Section 7. 569.015 (2) of the statutes is repealed.
16	Section 8. 569.03 (2) of the statutes is amended to read:
17	569.03 (2) Monitor the regulatory compliance of Indian gaming operations
18	under this chapter and under any Indian gaming compact entered into under s.
