



**ASSEMBLY AMENDMENT 17,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2005 ASSEMBLY BILL 100**

June 21, 2005 – Offered by Representative GRIGSBY.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 182, line 5: decrease the dollar amount for fiscal year 2005–06 by
3 \$72,000 and decrease the dollar amount for fiscal year 2006–07 by \$159,100 to
4 increase funding for benefits for pregnant women and decrease funding for newborn
5 infant grants under Wisconsin Works.

6 **2.** Page 483, line 22: after that line insert:

7 “**SECTION 1062c.** 49.148 (1m) (title) of the statutes is amended to read:

8 49.148 (**1m**) (title) CUSTODIAL PARENT OF INFANT; UNMARRIED, PREGNANT WOMAN.

9 **SECTION 1064c.** 49.148 (1m) (a) of the statutes is renumbered 49.148 (1m) (a)
10 (intro.) and amended to read:

11 49.148 (**1m**) (a) (intro.) ~~A~~ Any of the following may receive a monthly grant
12 of \$673:

1 1. An individual who meets the eligibility requirements under s. 49.145 (2) and
2 (3) and who is a custodial parent of a child who is 12 26 weeks old or less and who
3 ~~meets the eligibility requirements under s. 49.145 (2) and (3) may receive a monthly~~
4 ~~grant of \$673,~~ unless another adult member of the custodial parent's Wisconsin
5 ~~works~~ Works group is participating in, or is eligible to participate in, a Wisconsin
6 ~~works~~ Works employment position or is employed in unsubsidized employment, as
7 defined in s. 49.147 (1) (c).

11 positions. ~~Receipt of a grant under this subsection does not constitute participation~~

13 ~~49.145 (2) (n) or 49.147 (3) (c), (4) (b) or (5) (b) 2. if the child is born to the participant~~

17 **SECTION 1065c.** 49.148 (1m) (a) 2. of the statutes is created to read:

18 49.148 **(1m)** (a) 2. An unmarried woman who would be eligible under s. 49.145
19 except that she is not a custodial parent of a dependent child and who is in the 3rd
20 trimester of a pregnancy that is medically verified and shown by medical
21 documentation to be at risk and that renders the woman unable to participate in the
22 workforce.

23 **SECTION 1066c.** 49.148 (1m) (b) (intro.) of the statutes is created to read:

24 49.148 **(1m)** (b) (intro.) For purposes of the time limits under s. 49.145 (2) (n)
25 or 49.147 (3) (c), (4) (b), or (5) (b) 2., all of the following apply:

1 **SECTION 1068c.** 49.148 (1m) (b) of the statutes is renumbered 49.148 (1m) (b)
2 1. and amended to read:

3 49.148 **(1m)** (b) 1. Receipt of a grant under this subsection by a participant
4 under par. (a) 1. constitutes participation in a Wisconsin works Works employment
5 position ~~for purposes of the time limits under ss. 49.145 (2) (n) and 49.147 (3) (c), (4)~~
6 ~~(b) or (5) (b) 2. if the child is born to the participant more than 10 months after the~~
7 ~~date that the participant was first determined to be eligible for assistance under s.~~
8 ~~49.19 or for a Wisconsin works employment position unless the child was conceived~~
9 as a result of a sexual assault in violation of s. 940.225 (1), (2), or (3) in which the
10 mother did not indicate a freely given agreement to have sexual intercourse or of
11 incest in violation of s. 944.06 or 948.06 and that incest or sexual assault has been
12 reported to a physician and to law enforcement authorities.

13 **SECTION 1069c.** 49.148 (1m) (b) 2. of the statutes is created to read:

14 49.148 **(1m)** (b) 2. Receipt of a grant under this subsection by a participant
15 under par. (a) 2. does not constitute participation in a Wisconsin Works employment
16 position.”.

17 **3.** Page 486, line 15: delete lines 15 to 18 and substitute:

18 **“SECTION 1085c.** 49.159 (4) of the statutes is amended to read:

19 49.159 **(4)** PREGNANT WOMEN. A pregnant woman whose pregnancy is medically
20 verified, who would be eligible under s. 49.145 except that she is not a custodial
21 parent of a dependent child, and who does not satisfy the requirements under s.
22 49.148 (1m) (a) 2. is eligible for employment training and job search assistance
23 services provided by the Wisconsin works Works agency.”.

24 **4.** Page 487, line 11: delete “\$59,184,700” and substitute “\$59,526,100”.

1 **5.** Page 487, line 12: delete “\$51,930,000” and substitute “\$52,612,800”.

2 **6.** Page 488, line 11: delete “\$49,534,800” and substitute “\$49,879,200”.

3 **7.** Page 488, line 12: delete “\$43,463,000” and substitute “\$44,151,800”.

4 **8.** Page 488, line 23: delete “\$310,332,100” and substitute “\$307,282,800”.

5 **9.** Page 488, line 24: delete “\$313,432,100” and substitute “\$300,509,900”.

6 **10.** Page 1040, line 22: after that line insert:

7 “(1ck) GRANTS FOR CUSTODIAL PARENT OF INFANT UNDER WISCONSIN WORKS.

8 (a) *Eligibility.* The renumbering and amendment of section 49.148 (1m) (a)
9 (with respect to a custodial parent’s eligibility for a grant) of the statutes first applies
10 to individuals who are determined, on the effective date of this paragraph, to be
11 eligible for the Wisconsin Works program under sections 49.141 to 49.161 of the
12 statutes and to be custodial parents of children who are 26 weeks old or less.

13 (b) *Constituting participation in employment position.* The renumbering and
14 amendment of section 49.148 (1m) (a) (with respect to receipt of grants not
15 constituting participation in a Wisconsin Works employment position) and (b) of the
16 statutes and the creation of section 49.148 (1m) (b) (intro.) and 2. of the statutes first
17 apply to grants received under section 49.148 (1m) of the statutes on the effective
18 date of this paragraph.”.

19 **11.** Page 1051, line 10: after that line insert:

20 “(1ck) ELIGIBILITY OF CUSTODIAL PARENTS AND PREGNANT WOMEN FOR WISCONSIN
21 WORKS BENEFITS. The treatment of sections 49.148 (1m) (title) and 49.159 (4) of the
22 statutes, the renumbering and amendment of section 49.148 (1m) (a) and (b) of the

1 statutes, the creation of section 49.148 (1m) (a) 2. and (b) (intro.) and 2. of the
2 statutes, and SECTION 9354 (1ck) of this act take effect on January 1, 2006.”
