



**SENATE AMENDMENT 21,  
TO 2005 ASSEMBLY BILL 100**

June 29, 2005 – Offered by Senators RISSER and CARPENTER.

- 1           At the locations indicated, amend the engrossed bill as follows:
- 2           **1.** Page 8, line 15: delete lines 15 and 16.
- 3           **2.** Page 25, line 13: delete lines 13 to 22.
- 4           **3.** Page 27, line 18: delete that line.
- 5           **4.** Page 28, line 21: delete that line.
- 6           **5.** Page 29, line 1: delete the material beginning with “no” and ending with  
7           “each” and substitute “the department may sell any”.
- 8           **6.** Page 29, line 3: delete the material beginning with “shall” and ending with  
9           “2007.” on line 4 and substitute “may contract with a private entity for the operation  
10           of any such plant or facility if the department determines that such action is in the  
11           best interest of the state. The department shall consider security, operating and  
12           maintenance costs, operational efficiency, and delivery of services in making its  
13           determination.”.

1           **7.** Page 30, line 9: delete lines 9 to 22.

2           **8.** Page 254, line 17: delete lines 17 to 20.

3           **9.** Page 255, line 7: delete lines 7 to 10.

4           **10.** Page 255, line 18: delete lines 18 to 25.

5           **11.** Page 259, line 8: delete lines 8 to 16.

6           **12.** Page 282, line 13: delete lines 13 to 16.

7           **13.** Page 282, line 22: delete the material beginning with that line and ending  
8 with page 283, line 3.

9           **14.** Page 302, line 21: delete lines 21 to 25.

10          **15.** Page 305, line 19: delete lines 19 to 24.

11          **16.** Page 310, line 16: delete the material beginning with that line and ending  
12 with page 311, line 5.

13          **17.** Page 426, line 13: delete lines 13 to 18.

14          **18.** Page 932, line 12: delete the material beginning with that line and ending  
15 with page 933, line 2, and substitute:

16           “(10vf) AUTHORIZED POSITIONS. The authorized FTE positions for the  
17 department of administration, funded from the appropriation under section 20.505  
18 (5) (ka) of the statutes, are increased by 23.25 PR positions on April 1, 2007, for the  
19 purpose of operating state-owned utility plants under the jurisdiction of the  
20 department.”.

21          **19.** Page 964, line 21: after that line insert:

22           “(6f) AUTHORIZED POSITIONS.

1           (a) The authorized FTE positions for the department of corrections, funded  
2 from the appropriation under section 20.410 (1) (a) of the statutes, are increased by  
3 20.25 GPR positions on April 1, 2007, for the purpose of operating state-owned  
4 utility plants under the jurisdiction of the department.

5           (b) The authorized FTE positions for the department of corrections, funded  
6 from the appropriation under section 20.410 (1) (kk) are increased by 19.0 PR  
7 positions on April 1, 2007, for the purpose of operating state-owned utility plants  
8 under the jurisdiction of the department.

9           (c) The authorized FTE positions for the department of corrections, funded  
10 from the appropriation under section 20.410 (3) (hm) of the statutes, are increased  
11 by 5.0 PR positions on April 1, 2007, for the purpose of operating state-owned utility  
12 plants under the jurisdiction of the department.”.

13           **20.** Page 980, line 9: after that line insert:

14           “(15f) AUTHORIZED POSITIONS.

15           (a) The authorized FTE positions for the department of health and family  
16 services funded from the appropriation under section 20.435 (2) (gk) of the statutes,  
17 are increased by 34.0 PR positions on April 1, 2007, for the purpose of operating  
18 state-owned utility plants under the jurisdiction of the department.

19           (b) The authorized FTE positions for the department of health and family  
20 services, funded from the appropriation under section 20.435 (2) (kx) of the statutes,  
21 are increased by 7.0 PR positions on April 1, 2007, for the purpose of operating  
22 state-owned utility plants under the jurisdiction of the department.”.

23           **21.** Page 987, line 21: after that line insert:

1           “(6f) AUTHORIZED POSITIONS. The authorized FTE positions for the department  
2 of public instruction, funded from the appropriation under section 20.255 (1) (d) of  
3 the statutes, are increased by 10.0 GPR positions on April 1, 2007, for the purpose  
4 of operating state-owned utility plants under the jurisdiction of the department.”.

5           **22.** Page 1006, line 19: after that line insert:

6           “(10f) AUTHORIZED POSITIONS. The authorized FTE positions for the Board of  
7 Regents of the University of Wisconsin System, funded from the appropriation under  
8 section 20.285 (1) (a) of the statutes, are increased by 146.42 GPR positions on April  
9 1, 2007, for the purpose of operating state-owned utility plants under the  
10 jurisdiction of the board.”.

11          **23.** Page 1007, line 25: after that line insert:

12          “(4f) AUTHORIZED POSITIONS. The authorized FTE positions for the department  
13 of veterans affairs, funded from the appropriation under section 20.485 (1) (gk) of the  
14 statutes, are increased by 6.0 PR positions on April 1, 2007, for the purpose of  
15 operating state-owned utility plants under the jurisdiction of the department.”.

16          **24.** Page 1051, line 17: delete lines 17 to 22.
