



**SENATE AMENDMENT 6,
TO 2005 ASSEMBLY BILL 207**

September 27, 2005 – Offered by Senators ERPENBACH, RISSER, CARPENTER, MILLER
and TAYLOR.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 5, line 22: before that line insert:

3 “**SECTION 4r.** 111.337 (2) (d) of the statutes is created to read:

4 111.337 (2) (d) To require an employee who is a physician or pharmacist, and
5 who refuses, or states an intention to refuse, based on the employee’s creed, to
6 participate in an activity specified in sub. (1r) (b) 1. to 8., to post a notice described
7 under s. 448.03 (5) (au) or 450.135 (4).”.

8 **2.** Page 6, line 6: delete that line and substitute “~~or fetus.~~ A any of the
9 following:”.

10 **3.** Page 6, line 7: delete that line and substitute “(b) Except as provided in sub.
11 (4m), a physician or any other person who is a member of or associated with the”.

12 **4.** Page 6, line 15: delete “(c) A physician” and substitute “(c) Except as
13 provided in sub. (4m), a physician”.

1 **5.** Page 8, line 13: delete “No hospital A” and substitute “No hospital Except
2 as provided in sub. (4m), a”.

3 **6.** Page 8, line 19: delete “No hospital” and substitute “No hospital Except as
4 provided in sub. (4m), no”.

5 **7.** Page 9, line 19: after that line insert:

6 “**SECTION 13m.** 253.09 (4m) of the statutes is created to read:

7 253.09 (**4m**) Subsections (1r) (b) and (c), (2), and (3) do not apply to a physician
8 or pharmacist that fails to post the notice described under s. 448.03 (5) (au) or
9 450.135 (4).”.

10 **8.** Page 13, line 1: delete “No A person” and substitute “No Except as provided
11 in par. (au), a person”.

12 **9.** Page 14, line 15: delete “A person” and substitute “Except as provided in par.
13 (au), a person”.

14 **10.** Page 15, line 10: after that line insert:

15 “**SECTION 26m.** 448.03 (5) (au) of the statutes is created to read:

16 448.03 (**5**) (au) Paragraphs (am) and (an) do not apply to a physician unless the
17 physician posts at his or her place of employment in a location that is conspicuous
18 to patients a notice that states that the physician refuses to participate in a practice
19 within the scope of his or her license that is related to an activity specified in par. (am)
20 1. to 8. and that describes the practice that is related to the activity. An employer of
21 a physician, or an owner or operator of a physician’s place of employment, may not
22 prohibit a physician from posting a notice under this paragraph.”.

1 **11.** Page 16, line 1: delete "A person" and substitute "Except as provided in
2 sub. (5m), a person".

3 **12.** Page 16, line 22: delete "A person" and substitute "Except as provided in
4 sub. (5m), a person".

5 **13.** Page 17, line 14: after that line insert:

6 “(5m) Subsections (2) and (3) do not apply to a person licensed as a pharmacist
7 under this chapter unless the person posts at his or her place of employment in a
8 location that is conspicuous to patients a notice that states that the pharmacist
9 refuses to participate in a practice of pharmacy that is related to an activity specified
10 in sub. (2) (a) to (h) and that describes the practice that is related to the activity. An
11 employer of a pharmacist, or an owner or operator of a pharmacist’s place of
12 employment, may not prohibit a pharmacist from posting a notice under this
13 subsection.”.

14 **14.** Page 17, line 16: delete "and (1w)" and substitute ", (1w), and (2) (d)".

15 **15.** Page 17, line 17: before "and (5)" insert "(4m)".

16 **16.** Page 17, line 18: delete "and (ar)" and substitute "(ar), and (au)".
