**ASSEMBLY AMENDMENT 1,
TO 2005 ASSEMBLY BILL 36**

March 8, 2005 – Offered by Representative RICHARDS.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 5: delete “and”.

3 **2.** Page 1, line 5: after “prisoners” insert “, a state minimum wage, granting
4 rule-making authority, and providing a penalty”.

5 **3.** Page 2, line 1: before that line insert:

6 “**SECTION 1b.** 49.141 (1) (g) of the statutes is amended to read:

7 49.141 (1) (g) “Minimum wage” means the state minimum hourly wage under
8 ~~ch. 104 s. 104.035 (1)~~ or the federal minimum hourly wage under 29 USC 206 (a) (1),
9 whichever is applicable.

10 **SECTION 1bm.** 104.01 (intro.) of the statutes is amended to read:

11 **104.01 Definitions.** (intro.) ~~The following terms as used in ss. 104.01 to~~
12 ~~104.12 shall be construed as follows~~ In this chapter:

13 **SECTION 1c.** 104.01 (1) of the statutes is renumbered 104.01 (1m).

1 **SECTION 1cm.** 104.01 (1d) of the statutes is created to read:

2 104.01 (1d) “Agricultural employee” means an employee who is employed in
3 farming, as defined in s. 102.04 (3).

4 **SECTION 1d.** 104.01 (5) of the statutes is amended to read:

5 104.01 (5) ~~The term “living-wage” shall mean~~ “Living wage” means
6 compensation for labor paid, whether by time, piecework, or otherwise, sufficient to
7 enable the employee receiving it to maintain himself or herself under conditions
8 consistent with his or her welfare.

9 **SECTION 1dm.** 104.01 (5g) of the statutes is created to read:

10 104.01 (5g) “Minor employee” means a minor who is paid at the applicable
11 minimum wage rate for minors.

12 **SECTION 1e.** 104.01 (5m) of the statutes is created to read:

13 104.01 (5m) “Opportunity employee” means a person under 20 years of age who
14 is in the first 90 consecutive days of employment with his or her employer.

15 **SECTION 1em.** 104.01 (7m) of the statutes is created to read:

16 104.01 (7m) “Tipped employee” means an employee who in the course of
17 employment customarily and regularly receives money or other gratuities from
18 persons other than the employee’s employer.

19 **SECTION 1f.** 104.01 (8) of the statutes is amended to read:

20 104.01 (8) ~~The term “wage” and the term “wages” shall each mean~~ “Wage”
21 means any compensation for labor measured by time, piece, or otherwise.

22 **SECTION 1fm.** 104.02 of the statutes is amended to read:

23 **104.02 ~~Living-wage prescribed~~ Living wage required.** Every wage paid
24 or agreed to be paid by any employer to any employee, except as otherwise provided
25 in s. 104.07, shall be not less than a ~~living-wage~~ living wage.

1 **SECTION 1g.** 104.03 of the statutes is amended to read:

2 **104.03 Unlawful wages.** Any employer paying, offering to pay, or agreeing
3 to pay any employee a wage lower or less in value than a ~~living-wage~~ living wage is
4 guilty of a violation of ~~ss. 104.01 to 104.12~~ this chapter.

5 **SECTION 1gm.** 104.035 of the statutes is created to read:

6 **104.035 Minimum wage. (1) EMPLOYEES GENERALLY.** (a) *Minimum rates.*

7 Except as provided in subs. (2) to (8), the minimum wage is as follows:

- 8 1. For wages earned before October 1, 2005, \$5.70 per hour.
9 2. For wages earned beginning on October 1, 2005, \$6.50 per hour.

10 (b) *Allowances for meals and lodging.* Except as provided in subs. (2) (b) and
11 (4) (b), if an employer furnishes an employee with meals or lodging in accordance
12 with rules promulgated by the department under s. 104.045 (2), the employer may
13 deduct the following amounts from the wages of the employee:

14 1. For lodging furnished before October 1, 2005, \$45.60 per week or \$6.50 per
15 day and for meals furnished before October 1, 2005, \$68.40 per week or \$3.25 per
16 meal.

17 2. For lodging furnished beginning on October 1, 2005, \$52 per week or \$7.40
18 per day and for meals furnished beginning on October 1, 2005, \$78 per week or \$3.70
19 per meal.

20 **(2) MINOR AND OPPORTUNITY EMPLOYEES.** (a) *Minimum rates.* Except as provided
21 in subs. (3) to (8), the minimum wage for a minor employee or an opportunity
22 employee is as follows:

- 23 1. For wages earned before October 1, 2005, \$5.30 per hour.
24 2. For wages earned beginning on October 1, 2005, \$5.90 per hour.

1 (b) *Allowances for meals and lodging.* Except as provided in sub. (4) (b), if an
2 employer furnishes a minor employee or an opportunity employee with meals or
3 lodging in accordance with rules promulgated by the department under s. 104.045
4 (2), the employer may deduct the following amounts from the wages of the employee:

5 1. For lodging furnished before October 1, 2005, \$42.40 per week or \$6.05 per
6 day and for meals furnished before October 1, 2005, \$63.60 per week or \$3 per meal.

7 2. For lodging furnished beginning on October 1, 2005, \$47.20 per week or \$6.75
8 per day and for meals furnished beginning on October 1, 2005, \$70.80 per week or
9 \$3.35 per meal.

10 **(3) TIPPED EMPLOYEES.** (a) *Minimum rates.* Except as provided in subs. (4) to
11 (8), if an employer of a tipped employee establishes by the employer's payroll records
12 that, when adding the tips received by the tipped employee in a week to the wages
13 paid to the tipped employee in that week, the tipped employee receives not less than
14 the applicable minimum wage specified in sub. (1) or (2), the minimum wage for the
15 tipped employee is as follows:

16 1. For wages earned by a tipped employee who is not an opportunity employee,
17 \$2.33 per hour.

18 2. For wages earned by a tipped employee who is an opportunity employee,
19 \$2.13 per hour.

20 (b) *Allowances for meals and lodging.* If an employer furnishes a tipped
21 employee with meals or lodging in accordance with rules promulgated by the
22 department under s. 104.045 (2), the employer may deduct the applicable amounts
23 specified in subs. (1) (b) or (2) (b) from the wages of the tipped employee.

24 **(4) AGRICULTURAL EMPLOYEES.** (a) *Minimum rates.* Except as provided in subs.
25 (7) and (8), the minimum wage for an agricultural employee is as follows:

1 1. For wages earned by an adult agricultural employee, \$5.15 per hour.

2 2. For wages earned by a minor agricultural employee, \$4.25 per hour.

3 (b) *Allowances for meals and lodging.* If an employer furnishes an agricultural
4 employee with meals or lodging in accordance with rules promulgated by the
5 department under s. 104.045 (2), the employer may deduct the following amounts
6 from the wages of the employee:

7 1. For lodging furnished to an adult agricultural employee, \$41.20 per week or
8 \$5.90 per day and for meals furnished to an adult agricultural employee, \$61.80 per
9 week or \$2.95 per meal.

10 2. For lodging furnished to a minor agricultural employee, \$34 per week or
11 \$4.85 per day and for meals furnished to a minor agricultural employee, \$51 per week
12 or \$2.40 per meal.

13 **(5) CAMP COUNSELORS.** (a) *Minimum rates for adult counselors.* The minimum
14 wage for a counselor at a seasonal recreational or educational camp, including a day
15 camp, who is an adult is as follows:

16 1. For wages earned before October 1, 2005, \$215 per week if meals and lodging
17 are not furnished, \$164 per week if only meals are furnished, and \$129 per week if
18 both meals and lodging are furnished.

19 2. For wages earned beginning on October 1, 2005, \$270 per week if meals and
20 lodging are not furnished, \$217 per week if only meals are furnished, and \$171 per
21 week if both meals and lodging are furnished.

22 3. For wages earned beginning on October 1, 2006, \$315 per week if meals and
23 lodging are not furnished, \$240 per week if only meals are furnished, and \$189 per
24 week if both meals and lodging are furnished.

1 (b) *Minimum rates for minor counselors.* The minimum wage for a counselor
2 at a seasonal recreational or educational camp, including a day camp, who is a minor
3 is as follows:

4 1. For wages earned before October 1, 2005, \$175 per week if meals and lodging
5 are not furnished, \$133 per week if only meals are furnished, and \$105 per week if
6 both meals and lodging are furnished.

7 2. For wages earned beginning on October 1, 2005, \$225 per week if meals and
8 lodging are not furnished, \$171 per week if only meals are furnished, and \$135 per
9 week if both meals and lodging are furnished.

10 3. For wages earned beginning on October 1, 2006, \$275 per week if meals and
11 lodging are not furnished, \$209 per week if only meals are furnished, and \$165 per
12 week if both meals and lodging are furnished.

13 **(6) GOLF CADDIES.** The minimum wage for a golf caddy is as follows:

14 (a) For 18 holes, \$10.50.

15 (b) For 9 holes, \$5.90.

16 **(7) MINIMUM WAGE ESTABLISHED BY DEPARTMENT.** The department shall
17 promulgate rules providing the minimum wage for all of the following:

18 (a) An employee or worker with a disability covered under a license under s.
19 104.07.

20 (b) A student learner.

21 (c) A student employed by an independent college or university for less than
22 20 hours per week.

23 **(8) EMPLOYMENT EXEMPTED BY DEPARTMENT.** The department shall promulgate
24 rules exempting from the minimum wage requirements under subs. (1) to (7) all of
25 the following:

1 (a) A person engaged in casual employment in and around an employer's home
2 on an irregular or intermittent basis for not more than 15 hours per week.

3 (b) A person who resides with and who provides companionship and care, not
4 including practical or professional nursing, as defined in s. 441.001 (3) and (4), and
5 not more than 15 hours per week of general household work for an employer who, due
6 to advanced age or physical or mental disability, cannot care for his or her own needs.

7 (c) An elementary or secondary school student performing student work-like
8 activities in the student's school.

9 **(9) DEPARTMENT MAY REVISE.** The department may promulgate rules to increase
10 a minimum wage or an allowance for meals and lodging provided under subs. (1) to
11 (7).

12 **SECTION 1h.** 104.04 of the statutes is amended to read:

13 **104.04 Classifications; department's authority.** The department shall
14 investigate, ascertain, determine, and fix such reasonable classifications, and shall
15 impose general or special orders, determining the ~~living-wage~~ living wage, and shall
16 carry out the purposes of ~~ss. 104.01 to 104.12.~~ Such this chapter. ~~Those~~
17 investigations, classifications, and orders shall be made as provided under s.
18 103.005, and the penalties specified in s. 103.005 (12) shall apply to and be imposed
19 for any violation of ~~ss. 104.01 to 104.12~~ this chapter. In determining the ~~living-wage~~
20 living wage, the department may consider the effect that an increase in the
21 ~~living-wage~~ living wage might have on the economy of the state, including the effect
22 of a ~~living-wage~~ living wage increase on job creation, retention, and expansion, on
23 the availability of entry-level jobs, and on regional economic conditions within the
24 state. The department may not establish a different minimum wage for men and

1 women. Said Those orders shall be subject to review in the manner provided in ch.
2 227.

3 **SECTION 1hm.** 104.045 of the statutes is renumbered 104.045 (intro.) and
4 amended to read:

5 **104.045 ~~Tipped employees~~ Tips, meals, lodging, and hours worked.**
6 (intro.) The department shall ~~by rule determine what amount of~~ promulgate rules
7 governing all of the following:

8 (1) The counting of tips or similar gratuities ~~may be counted~~ toward fulfillment
9 of the employer's obligation under this chapter.

10 **SECTION 1i.** 104.045 (2) and (3) of the statutes are created to read:

11 104.045 (2) The deduction of meals or lodging provided by an employer to an
12 employee from the employer's obligation under this chapter.

13 (3) The determination of hours worked by an employee during which the
14 employee is entitled to a living wage under this chapter.

15 **SECTION 1im.** 104.05 of the statutes is amended to read:

16 **104.05 Complaints; investigation.** The department shall, within 20 days
17 after the filing of a verified complaint of any person ~~setting forth~~ alleging that the
18 wages paid to any employee ~~in any occupation~~ are not sufficient to enable the
19 employee to maintain himself or herself under conditions consistent with his or her
20 welfare, investigate and determine whether there is reasonable cause to believe that
21 the wage paid to any ~~the~~ employee is not a ~~living-wage~~ living wage.

22 **SECTION 1j.** 104.06 of the statutes is amended to read:

23 **104.06 Wage council; determination.** If, upon investigation, the
24 department finds that there is reasonable cause to believe that the wages paid to any
25 employee are not a ~~living-wage, it~~ living wage, the department shall appoint a wage

1 council, selected so as fairly to represent employers, employees, and the public, to
2 assist in its investigations and determinations. The ~~living-wage~~ department may
3 use the results of an investigation under this section to establish a living wage. A
4 living wage so determined upon shall be the ~~living-wage~~ living wage for all
5 employees within the same class as established by the ~~classification of the~~
6 department under s. 104.04.

7 **SECTION 1jm.** 104.07 (1) of the statutes is amended to read:

8 104.07 (1) The department shall ~~make~~ promulgate rules and, except as
9 provided under subs. (5) and (6), grant licenses, to any employer who employs any
10 employee who is unable to earn the ~~living-wage theretofore determined upon,~~
11 ~~permitting such person to~~ a living wage so that the employee may work for a wage
12 ~~which shall be that is~~ commensurate with the employee's ability and each. Each
13 license so granted shall establish a wage for the licensee employees of the licensee
14 who are unable to earn a living wage.

21 under this section may be issued for the entire workshop or a department of the

2 threatens to discharge, or who in any way discriminates, or threatens to
3 discriminate, against any employee because the employee has testified or is about
4 to testify, or because the employer believes that the employee may testify, in any
5 investigation or proceeding relative to the enforcement of ~~ss. 104.01 to 104.12~~, is

19 other discriminatory acts arising in connection with any proceeding under this
20 section.

22 234.94 (5) "Primary employment" means work ~~which~~ that pays at least the
23 minimum wage as established under ~~ch. 104 s. 104.035 (1)~~ or under federal law,
24 whichever is greater, offers adequate fringe benefits, including health insurance,
25 and is not seasonal or part time.

1 **SECTION 1p.** 234.94 (8) of the statutes is amended to read:

2 234.94 (8) “Target group” means a population group for which the
3 unemployment level is at least 25% higher than the statewide unemployment level,
4 or a population group for which the average wage received is less than 1.2 times the
5 minimum wage as established under ~~ch. 104 s. 104.035 (1)~~ or under federal law,
6 whichever is greater. No population group is required to be located within a
7 contiguous geographic area to be considered a target group.”.

10 “**SECTION 8g.** 800.09 (1) (b) of the statutes is amended to read:

11 800.09 (1) (b) If the defendant agrees to perform community service work in
12 lieu of making restitution or paying the forfeiture, assessments, and costs, or both,
13 the court may order that the defendant perform community service work for a public
14 agency or a nonprofit charitable organization that is designated by the court.
15 Community service work may be in lieu of restitution only if also agreed to by the
16 public agency or nonprofit charitable organization and by the person to whom
17 restitution is owed. The court may utilize any available resources, including any
18 community service work program, in ordering the defendant to perform community
19 service work. The number of hours of community service work required may not
20 exceed the number determined by dividing the amount owed on the forfeiture by the

8 any community service work program, in ordering the defendant to perform
9 community service work. The number of hours of community service work required
10 may not exceed the number determined by dividing the amount owed on the
11 forfeiture, or restitution, or both, by the minimum wage established under ~~ch. 104~~
12 ~~for adults in nonagriculture, nontipped employment s. 104.035 (1).~~ The court shall
13 ensure that the defendant is provided a written statement of the terms of the
14 community service order and that the community service order is monitored.

15 **SECTION 8r.** 895.035 (2m) (c) of the statutes is amended to read:

16 895.035 (2m) (c) The court assigned to exercise jurisdiction under chs. 48 and
17 938 may order that the juvenile perform community service work for a public agency
18 or nonprofit charitable organization that is designated by the court in lieu of making
19 restitution or paying the forfeiture or surcharge. If the parent agrees to perform
20 community service work in lieu of making restitution or paying the forfeiture or
21 surcharge, the court may order that the parent perform community service work for
22 a public agency or a nonprofit charitable organization that is designated by the court.
23 Community service work may be in lieu of restitution only if also agreed to by the
24 public agency or nonprofit charitable organization and by the person to whom
25 restitution is owed. The court may utilize any available resources, including any

1 community service work program, in ordering the juvenile or parent to perform
2 community service work. The number of hours of community service work required
3 may not exceed the number determined by dividing the amount owed on the
4 restitution, forfeiture, or surcharge by the minimum wage established under ~~ch. 104~~
5 ~~for adults in nonagriculture, nontipped employment s. 104.035 (1)~~. The court shall
6 ensure that the juvenile or parent is provided with a written statement of the terms
7 of the community service order and that the community service order is monitored.”.

10 (5m), (7m), and (8), 104.02, 104.03, 104.035, 104.04, 104.05, 104.06, 104.07 (1) and
11 (2), 104.08 (1), (1m) (b), and (2), 104.10, 104.11, 104.12, 234.94 (5) and (8), 800.09 (1)
12 (b), 800.095 (4) (b) 3., and 895.035 (2m) (c) of the statutes, the renumbering and
13 amendment of sections 104.045 and 104.08 (3) of the statutes, and the creation of
14 sections 104.045 (2) and (3) and 104.08 (3) (a) of the statutes take effect on the first
15 day of the 3rd month beginning after publication.”.
