March 20, 2008 – Offered by COMMITTEE ON FINANCE.

1 At the locations indicated, amend the bill, as shown by assembly bill 1, as
2 follows:

3 **1.** Page 3, line 15: after that line insert:

4 “**SECTION 1g.** 13.101 (18) of the statutes is created to read:

5 13.101 (18) Notwithstanding sub. (4), the committee may not transfer moneys
6 from the appropriation account under s. 20.435 (4) (xc) to another appropriation
7 account.”.

8 **2.** Page 4, line 16: after that line insert:

9 “**SECTION 6m.** 20.005 (3) (schedule) of the statutes: at the appropriate place,
10 insert the following amounts for the purposes indicated:

3. Page 4, line 18: on lines 18 and 20, delete “\$20,000,000” and substitute
“\$55,000,000”.

4. Page 4, line 25: after that line insert:

“**SECTION 9ac.** 20.435 (4) (gp) of the statutes is repealed.

SECTION 9ad. 20.435 (4) (xc) of the statutes is created to read:

20.435 (4) (xc) *Hospital assessment fund; hospital payments and refunds.*

Biennially, from the medical assessment trust fund, the amounts in the schedule for increased payments and refunds to hospitals and for higher capitated payment rates under s. 49.45 (58) (a), as the Medical Assistance nonfederal share, in order to increase payment rates in excess of the aggregate inpatient and outpatient hospital payment rates in effect in fiscal year 2006-07 for services provided by hospitals under the Medical Assistance program administered under subch. IV of ch. 49.

SECTION 9ae. 20.435 (4) (xd) of the statutes is created to read:

1 20.435 (4) (xd) *Hospital assessment fund; Medical Assistance program benefits.*
2 Biennially, from the hospital assessment fund, the amounts in the schedule to
3 provide a portion of the state share of Medical Assistance program benefits
4 administered under subch. IV of ch. 49.

5 **SECTION 9af.** 20.566 (1) (ho) of the statutes is created to read:

6 20.566 (1) (ho) *Collections under multistate streamlined sales tax project.* From
7 moneys collected under the multistate streamlined sales tax project as provided
8 under s. 73.03 (28e), a sum sufficient to pay the dues necessary to participate in the
9 governing board of the multistate streamlined sales tax project.

10 **SECTION 9ag.** 20.866 (2) (uur) of the statutes is amended to read:

11 20.866 (2) (uur) *Transportation; state highway rehabilitation projects.* From
12 the capital improvement fund, a sum sufficient for the department of transportation
13 to fund state highway rehabilitation projects, as provided under s. 84.95. The state
14 may contract public debt in an amount not to exceed ~~\$250,000,000~~ \$300,000,000 for
15 this purpose.

16 **SECTION 9ah.** 25.17 (1) (gs) of the statutes is created to read:

17 25.17 (1) (gs) Hospital assessment fund (s. 25.772);

18 **SECTION 9ai.** 25.69 of the statutes, as affected by 2007 Wisconsin Act 20, is
19 amended to read:

20 **25.69 Permanent endowment fund.** There is established a separate
21 nonlapsible trust fund designated as the permanent endowment fund, consisting of
22 all of the proceeds from the sale of the state's right to receive payments under the
23 Attorneys General Master Tobacco Settlement Agreement of November 23, 1998,
24 and all investment earnings on the proceeds. There is transferred from the

1 permanent endowment fund to the Medical Assistance trust fund \$50,000,000
2 \$68,000,000 in each fiscal year.

3 **SECTION 9aj.** 25.772 of the statutes is created to read:

4 **25.772 Hospital assessment fund.** There is established a separate
5 nonlapsible trust fund designated as the hospital assessment fund, to consist of all
6 moneys received under s. 50.375 from assessments on hospitals.

7 **SECTION 9ak.** 46.27 (9) (a) of the statutes is amended to read:

8 46.27 (9) (a) The department may select up to 5 counties that volunteer to
9 participate in a pilot project under which they will receive certain funds allocated for
10 long-term care. The department shall allocate a level of funds to these counties
11 equal to the amount that would otherwise be paid under s. 20.435 (4) (b), ~~(gp)~~, or (w),
12 or (xd), to nursing homes for providing care because of increased utilization of
13 nursing home services, as estimated by the department. In estimating these levels,
14 the department shall exclude any increased utilization of services provided by state
15 centers for the developmentally disabled. The department shall calculate these
16 amounts on a calendar year basis under sub. (10).

17 **SECTION 9aL.** 46.27 (10) (a) 1. of the statutes is amended to read:

18 46.27 (10) (a) 1. The department shall determine for each county participating
19 in the pilot project under sub. (9) a funding level of state medical assistance
20 expenditures to be received by the county. This level shall equal the amount that the

22 or (xd), or because of increased utilization of nursing home services, as estimated by
23 the department.

8 occasions on which the provider significantly overreported the attendance of a child.

10 payment for units of service used by each child, up to the maximum number of
11 authorized units, except as provided in par. (c).

12 (c) A child care administrative agency may authorize payment to a licensed or
13 certified provider to hold a slot for a child if the child's parent has a temporary break
14 in employment and intends to return to work and to continue to use the services of
15 the provider upon returning to work. The child care administrative agency may
16 authorize payment for no more than 6 weeks if the absence is due to a medical reason
17 and is documented by a physician or for no more than 4 weeks if the absence is due
18 to another reason. The department and child care administrative agency may not
19 consider payment for a temporary absence to be an overpayment if the parent
20 intended to, but does not actually, return to work.

2 department shall develop a methodology for calculating rate increases for inpatient
3 and outpatient hospital services in connection with the assessment imposed on
4 hospitals under s. 50.375. The methodology shall incorporate encounter data
5 provided by health maintenance organizations and information that the department
6 uses to calculate the capitated rates that the department pays health maintenance
7 organizations for providing services to recipients of medical assistance. The
8 department shall publicly disclose the methodology. The department shall review
9 the methodology at least once every 12 months.

10 (b) The department shall require, as a term of contracts with health
11 maintenance organizations to provide medical assistance services, that the health
12 maintenance organization do all of the following:

14 under par. (a), to hospitals that serve medical assistance recipients who are enrolled
15 in the health maintenance organization.

16 2. Calculate the amounts that result from applying the rate increases that are
17 derived using the methodology under par. (a) to services for recipients of medical
18 assistance for which hospitals submit claims to the health maintenance
19 organization.

20 3. Within 90 days after the end of each 6-month period, compare the amounts
21 that the health maintenance organization paid hospitals under subd. 1. for the
22 6-month period with the amounts calculated under subd. 2. for services provided
23 during that same period. If the amounts under subd. 2. exceed the amounts of the
24 payments under subd. 1., pay hospitals the difference within 90 days.

1 (c) If the amounts that a health maintenance organization paid hospitals under
2 par. (b) 1. for a 6-month period exceed the amounts calculated under par. (b) 2. for
3 services provided during the same period, hospitals shall pay the health
4 maintenance organization the difference within 90 days after the comparison of
5 amounts under par. (b) 3. is completed.

6 (d) If the department determines that a health maintenance organization has
7 not complied with a condition under par. (b), the department shall require the health
8 maintenance organization to comply with the condition within 15 days after the
9 department's determination. The department may terminate a contract with a
10 health maintenance organization for failure to comply with a condition under par.
11 (b). The department shall audit health maintenance organizations to determine
12 whether they have complied with the conditions under par. (b).

13 (e) If a health maintenance organization and hospital cannot resolve the
14 amount that a health maintenance organization owes a hospital under par. (b) 3. or
15 that a hospital owes a health maintenance organization under par. (c), and either the
16 health maintenance organization or the hospital, within 6 months after the end of
17 the time period to which the disputed amount relates, requests that the department
18 determine the amount owed, the department shall determine the amount within 90
19 days after the request is made. The health maintenance organization or hospital is,
20 upon request, entitled to a contested case hearing under ch. 227 on the department's
21 determination.

25 individual who is eligible for medical assistance under sub. (3), pay premiums for or

1 purchase individual coverage offered by the individual's employer if the department
2 determines that paying the premiums for or purchasing the coverage will not be more
3 costly than providing medical assistance.

5 49.472 (6) (b) If federal financial participation is available, from the

8 medicare and for medical assistance under sub. (3).

9 **SECTION 9cd.** 49.473 (5) of the statutes is amended to read:

10 49.473 (5) The department shall audit and pay, from the appropriation
11 accounts under s. 20.435 (4) (b), ~~(gp), and (o), and (xd)~~, allowable charges to a provider
12 who is certified under s. 49.45 (2) (a) 11. for medical assistance on behalf of a woman
13 who meets the requirements under sub. (2) for all benefits and services specified
14 under s. 49.46 (2).

15 **SECTION 9ce.** 50.375 of the statutes is created to read:

16 **50.375 Assessment.** (1) Except as provided in subs. (2) and (7), for the
17 privilege of doing business in this state, there is imposed on each hospital an annual
18 assessment, based on the hospital's gross patient revenue, that each hospital shall
19 pay quarterly by September 1, December 1, March 1, and June 1 of each year,
20 beginning with the payment due by September 1, 2008, except that the entire annual
21 assessment for fiscal year 2007–08 shall be paid by June 1, 2008. The assessments
22 shall be deposited into the hospital assessment fund.

23 (2) At the discretion of the department, a hospital that is unable timely to make
24 a payment by a date specified under sub. (1) may be allowed to make a delayed
25 payment. A determination by the department that a hospital may not make a

1 delayed payment under this subsection is final and is not subject to review under ch.
2 227.

3 (3) The amount of each hospital's assessment shall be based on the information
4 that shall be provided to the department under s. 153.46 (5) or shall be based on any
5 other source that is approved in the state plan for services under 42 USC 1396.

6 (4) The department shall verify the amount of each hospital's gross patient
7 revenue and shall determine the amount of the assessment owed by each hospital
8 based on a uniform rate that is applicable to total gross patient revenue that the
9 department estimates will yield the amounts specified in the appropriation schedule
10 under s. 20.005 (3) for the appropriation accounts under s. 20.435 (4) (xc) and (xd).

11 (5) The department shall levy, enforce, and collect the assessments under this
12 section and shall develop and distribute forms necessary for these purposes.

13 (6) If the department determines that any portion of the revenue collected
14 under sub. (5) to provide Medical Assistance program benefits and payment
15 increases for inpatient and outpatient hospital services as fee for service or through
16 health maintenance organizations or to support the Medical Assistance Program is
17 not eligible for federal financial participation, the department will refund that
18 amount of revenue to hospitals in proportion to each hospital's payment of the
19 assessment.

20 (7) This section does not apply to a critical access hospital, as defined in s. 50.33
21 (1g), or to an institution for mental diseases, as defined in s. 46.011 (1m).

22 (8) Sections 77.59 (1) to (5), (6) (intro.), (a), and (c), and (7) to (10), 77.60 (1) to
23 (7), (9), and (10), 77.61 (9) and (12) to (14), and 77.62, as they apply to the taxes under
24 subch. III of ch. 77, apply to the assessment under this section, except that the

1 amount of any assessment collected under sub. (1) shall be deposited in the hospital
2 assessment fund.

3 (9) By December 31, 2008, and by every December 31 thereafter, the
4 department shall report to the joint committee on finance all of the following
5 information for the immediately previous state fiscal year:

6 (a) The total amount of assessments collected under this section.

7 (b) The total amount of assessments collected from each hospital under this
8 section.

9 (c) The total amounts that the department determines were paid to health
10 maintenance organizations for increased Medical Assistance payments to hospitals.

11 (d) The total amount of payments made to each hospital by health maintenance
12 organizations under s. 49.45 (58) (b) 1.

18 value to the separate parts and the two corporations are members of the same
19 commonly controlled group.

14 b. The amount of the member’s payroll that is paid in the United States,
15 including the District of Columbia and any territory or possession of the United
16 States, divided by the amount of the member’s total payroll. For purposes of this
17 subd. 2. b., payroll includes compensation paid to employees, but does not include
18 payroll used to produce nonapportionable income. The payroll paid in the United
19 States, including the District of Columbia and any territory or possession of the
20 United States, shall be determined in the same manner as payroll is determined for
21 this state under s. 71.25 (8) (b) 1. to 5.

22 c. The member’s sales in the United States, including the District of Columbia
23 and any territory or possession of the United States, divided by the member’s total

7 4. Any member that is a controlled foreign corporation as defined in section 957

11 to federal treaties, and the apportionment factors related to that income. For

5 combined group, the taxpayer member has a net business loss, subject to the net
6 business loss limitations and carry-forward provisions in s. 71.26 (4). The business
7 loss is applied as a deduction in a subsequent year only if the taxpayer member has
8 net income sourced to this state, regardless of whether the taxpayer is a member of
9 a combined group in the subsequent year.

12 (a) Compute the sum of the income of each member of the combined group as

21 2. Except as provided in subd. 3, for any member not included in subd. 1., the
22 income included in the total income of the combined group shall be determined as

1 a. Each foreign branch or foreign corporation shall prepare a profit and loss
2 statement in the currency in which the branch's or corporation's books of account are
3 regularly maintained.

4 b. The member shall adjust any statement prepared under subd. 2. a. to
5 conform to the accounting principles generally accepted in the United States for the
6 preparation of profit and loss statements.

7 c. The member shall adjust any statement prepared under subd. 2. a. to
8 conform to the tax accounting standards required by the department for the
9 administration of this chapter.

10 d. Each member of the combined group shall translate its profit and loss
11 statements, and the related apportionment factors, into the currency in which the

13 e. Each member shall express in U.S. dollars the income apportioned to this

16 subsection reasonably approximates income as determined under s. 71.26, any
17 member not included in subd. 1. may determine its income based on a consolidated
18 profit and loss statement that includes the member and that is prepared for the
19 purpose of filing, by related corporations, with the securities and exchange
20 commission. If the member is not required to file with the securities and exchange
21 commission, the department may allow, for purposes of this subdivision, the use of
22 the consolidated profit and loss statement prepared for reporting to shareholders
23 and subject to review by an independent auditor. If a statement described in this
24 subdivision does not reasonably approximate income as determined under s. 71.26,
25 the department may accept the statement if the member makes appropriate

1 adjustments to the statement, as determined by the department, to approximate the
2 income determined under s. 71.26.

3 4. If a unitary business includes income from a pass-through entity, the total
4 income of the combined group includes the member's direct and indirect distributive
5 share of the pass-through entity's unitary business income.

6 5. All dividends paid by one member to another are not included in the
7 recipients income, if the dividends are paid out of the earnings and profits of the
8 unitary business in the current taxable year or in an earlier taxable year. This
9 subdivision does not apply to dividends received from members of a unitary business
10 that are not a part of the combined group.

11 6. Except as provided by the department by rule, business income or loss from
12 an intercompany transaction between members of the same combined group shall be
13 deferred in a manner similar to 26 CFR 1.1502-13. Upon the occurrence of any of
14 the following events, deferred business income or loss resulting from an
15 intercompany transaction between members of a combined group shall be included
16 in the income of the seller and shall be apportioned as business income earned
17 immediately before the event:

18 a. The object of the deferred intercompany transaction is sold by the buyer to
19 an entity that is not a member of the combined group.

20 b. The object of the deferred intercompany transaction is sold by the buyer to
21 an entity that is a member of the combined group for use outside the unitary business
22 in which the buyer and seller are engaged.

23 c. The object of the deferred intercompany transaction is converted by the buyer
24 to a use outside the unitary business in which the buyer and seller are engaged.

1 d. The buyer and seller are no longer members of the same combined group,
2 regardless of whether the members remain a unitary business.

3 7. A charitable expense incurred by a member of a combined group, to the
4 extent allowable as a deduction under section 170 of the Internal Revenue Code,
5 shall be subtracted first from the business income of the combined group, subject to
6 the income limitations of section 170 of the Internal Revenue Code as it applies to
7 the entire business income of the group, and any remaining amount shall be treated
8 as a nonbusiness expense allocable to the member that incurred the expense, subject
9 to the income limitations of section 170 of the Internal Revenue Code as it applies
10 to the nonbusiness income of that member. Any charitable deduction described
11 under this subdivision that is allowed as a carryover deduction in a subsequent year
12 is considered to be originally incurred in the subsequent year by the same member,
13 and this section applies in the subsequent year for purposes of determining the
14 allowable deduction in that year.

21 conversions, the business gain and loss of all members are combined within each
22 class of net business gain or loss and each such class is separately apportioned to each
23 member using the member's apportionment percentage determined under sub. (5).

24 b. Each taxpayer member shall net its apportioned business gain or loss for all
25 classes, as determined under subd. 8. a., including any such apportioned business

1 gain and loss from other combined groups, against the taxpayer member's
2 nonbusiness gain and loss for all classes allocated to this state as provided under
3 sections 1231 and 1222 of the Internal Revenue Code, not including nonbusiness
4 items allocated to another state.

5 c. Any resulting state source income or loss, if the loss is not subject to section
6 1211 of the Internal Revenue Code, of a taxpayer member produced by the
7 application of subd. 8. a. and b. shall then be applied to all other state source income
8 or loss of that member.

9 d. Any resulting state source loss of a member that is subject to section 1211
10 of the Internal Revenue Code shall be carried forward or carried back by that
11 member and shall be treated as state source short-term capital loss incurred by that

14 indirectly attributable to the nonbusiness or exempt income of another member of
15 the unitary business shall be allocated to that other member as corresponding
