**SENATE AMENDMENT 8,  
TO SENATE SUBSTITUTE AMENDMENT 1,  
TO 2007 SENATE BILL 40**

June 26, 2007 – Offered by Senators KAPANKE, DARLING, LAZICH, HARSDORF, COWLES, ELLIS, S. FITZGERALD, GROTHMAN, KANAVAS, KEDZIE, A. LASEE, LEIBHAM, OLSEN, ROESSLER and SCHULTZ.

1 At the locations indicated, amend the substitute amendment as follows:

10 may be divided into 3 allotments: personal services, other operating expenses and  
11 capital outlay or such other meaningful classifications as may be approved by the  
12 joint committee on finance.”.
