



**ASSEMBLY AMENDMENT 2,
TO 2009 ASSEMBLY BILL 21**

October 29, 2009 – Offered by Representative SCHNEIDER.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 13: delete “accident.” and substitute “accident, unless at the
time of the accident the operator was driving or operating a motor vehicle as follows:

3 (a) While under the influence of alcohol, a controlled substance, a controlled
4 substance analog, or any combination of alcohol, a controlled substance, or a
5 controlled substance analog.

6 (b) While under the influence of any other drug, or under the combined
7 influence of alcohol and any other drug, to a degree that rendered the operator
8 incapable of safely driving.

9 (c) While having a restricted controlled substance in his or her blood.

10 (d) While having a prohibited alcohol concentration, as defined in s. 340.01
11 (46m), or, if the operator was driving or operating a commercial motor vehicle, an
12 alcohol concentration of 0.04 or more.”.

1 **2.** Page 4, line 1: delete lines 1 to 10 and substitute:
