**ASSEMBLY SUBSTITUTE AMENDMENT 2,
TO 2009 ASSEMBLY BILL 594**

March 3, 2010 – Offered by Representatives STASKUNAS and GUNDRUM.

1 **AN ACT to amend** 51.37 (10) (a) 4., 301.046 (4) (a) 2., 301.048 (4m) (a) 2., 301.38
2 (1) (b), 302.105 (1) (b), 302.1135 (7) (a), 302.114 (6) (a), 303.068 (4m) (a) 2.,
3 304.06 (1) (a) 2., 304.063 (1) (b), 304.09 (1) (b) and 971.17 (4m) (a) 3. of the
4 statutes; **relating to:** notifying a law enforcement agency when certain
5 persons are released from the custody of the Department of Corrections.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 **SECTION 1.** 51.37 (10) (a) 4. of the statutes is amended to read:
7 51.37 (10) (a) 4. “Victim” means a person against whom a crime has been
8 committed and includes, if the inmate was convicted of an offense under s. 940.01,
9 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
10 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
11 on which the officer served and the head of the collective bargaining unit, if any, for
12 that law enforcement agency.

1 **SECTION 2.** 301.046 (4) (a) 2. of the statutes is amended to read:

2 301.046 (4) (a) 2. “Victim” means a person against whom a crime has been
3 committed and includes, if the inmate was convicted of an offense under s. 940.01,
4 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
5 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
6 on which the officer served and the head of the collective bargaining unit, if any, for
7 that law enforcement agency.

19 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
20 on which the officer served and the head of the collective bargaining unit, if any, for
21 that law enforcement agency.

22 **SECTION 5.** 302.105 (1) (b) of the statutes is amended to read:

23 302.105 (1) (b) “Victim” means a person against whom a crime has been
24 committed and includes, if the inmate was convicted of an offense under s. 940.01,
25 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was

1 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
2 on which the officer served and the head of the collective bargaining unit, if any, for
3 that law enforcement agency.

4 **SECTION 6.** 302.1135 (7) (a) of the statutes, as affected by 2009 Wisconsin Act
5 28, is amended to read:

6 302.1135 (7) (a) In this subsection, “victim” has the meaning given in s. 950.02
7 (4) and includes, if the inmate was convicted of an offense under s. 940.01, 940.02,
8 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was a law
9 enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency on
10 which the officer served and the head of the collective bargaining unit, if any, for that
11 law enforcement agency.

12 **SECTION 7.** 302.114 (6) (a) of the statutes is amended to read:

13 302.114 (6) (a) In this subsection, “victim” has the meaning given in s. 950.02
14 (4) and includes, if the inmate was convicted of an offense under s. 940.01, 940.02,
15 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was a law
16 enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency on
17 which the officer served and the head of the collective bargaining unit, if any, for that
18 law enforcement agency.

19 **SECTION 8.** 303.068 (4m) (a) 2. of the statutes is amended to read:

20 303.068 (4m) (a) 2. “Victim” means a person against whom a crime has been
21 committed and includes, if the inmate was convicted of an offense under s. 940.01,
22 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
23 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
24 on which the officer served and the head of the collective bargaining unit, if any, for
25 that law enforcement agency.

1 **SECTION 9.** 304.06 (1) (a) 2. of the statutes is amended to read:

2 304.06 (1) (a) 2. “Victim” means a person against whom a crime has been
3 committed and includes, if the inmate was convicted of an offense under s. 940.01,
4 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
5 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
6 on which the officer served and the head of the collective bargaining unit, if any, for
7 that law enforcement agency.

8 **SECTION 10.** 304.063 (1) (b) of the statutes is amended to read:

9 304.063 (1) (b) “Victim” means a person against whom a crime has been
10 committed and includes, if the inmate was convicted of an offense under s. 940.01,
11 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
12 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
13 on which the officer served and the head of the collective bargaining unit, if any, for
14 that law enforcement agency.

15 **SECTION 11.** 304.09 (1) (b) of the statutes is amended to read:

16 304.09 (1) (b) “Victim” means a person against whom a crime has been
17 committed and includes, if the inmate was convicted of an offense under s. 940.01,
18 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was
19 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
20 on which the officer served and the head of the collective bargaining unit, if any, for
21 that law enforcement agency.

22 **SECTION 12.** 971.17 (4m) (a) 3. of the statutes is amended to read:

24 committed and includes, if the inmate was convicted of an offense under s. 940.01,
25 940.02, 940.03, 940.05, 940.06, 940.08, 940.09, or 940.10 and the person killed was

1 a law enforcement officer, as defined in s. 102.475 (8) (c), the law enforcement agency
2 on which the officer served and the head of the collective bargaining unit, if any, for
3 that law enforcement agency.

4 **SECTION 13. Initial applicability.**

5 (1) This act first applies to a release, placement, or escape that occurs, or a
6 petition that is filed, on the effective date of this subsection.
