7           tangible personal property or items, property, or goods under s. 77.52 (1) (b), (c), or  
8           (d), or of tangible personal property or items, property, or goods under s. 77.52 (1) (b),  
9           (c), or (d) on which taxable services were performed, to purchasers in a county or  
10           special district are doing business in that county or special district, and that county  
11           or special district has jurisdiction to impose the taxes under this subchapter on them.
- 12           **SECTION 1864mb.** 77.73 (3) of the statutes, as created by 2009 Wisconsin Act  
13           2, is amended to read:
- 14           77.73 (3) Counties and special districts have jurisdiction to impose the taxes  
15           under this subchapter on retailers who file, or who are required to file, an application  
16           under s. 77.52 (7) or who register, or who are required to register, under s. 77.53 (9)  
17           or (9m), regardless of whether such retailers are engaged in business in the county  
18           or special district, as provided in s. 77.51 (13g). A retailer who files, or is required  
19           to file, an application under s. 77.52 (7) or who registers, or who is required to  
20           register, under s. 77.53 (9) or (9m) shall collect, report, and remit to the department  
21           the taxes imposed under this subchapter for all counties and special districts that  
22           have an ordinance or resolution imposing the taxes under this subchapter.”.
