## "SECTION 44m. Fiscal changes.

(1) ASSISTANT DISTRICT ATTORNEY POSITION; BROWN COUNTY. In the schedule 4  $\mathbf{5}$ under section 20.005 (3) of the statutes for the appropriation to the department of 6 administration under section 20.475 (1) (d) of the statutes, as affected by the acts of 7 2011, the dollar amount is increased by \$100,700 for fiscal year 2011–12 to increase the authorized FTE assistant district attorney position in Brown County by 1.0 GPR 8 9 position to manage additional workload generated by sections 907.01 and 907.02 of 10 the statutes, as affected by this act, including expert witness hearings held pursuant 11 to section 907.02 of the statutes, as affected by this act. In the schedule under section 1220.005 (3) of the statutes for the appropriation to the department of administration 13under section 20.475 (1) (d) of the statutes, as affected by the acts of 2011, the dollar

1 amount is increased by \$108,000 for fiscal year 2012-13 to provide funding for the  $\mathbf{2}$ position authorized under this subsection.

In the schedule under section 20.005 (3) of the statutes for the 13appropriation to the department of administration under section 20.475 (1) (d) of the 14 statutes, as affected by the acts of 2011, the dollar amount is increased by \$108,000 15for fiscal year 2012-13 to provide funding for the position authorized under this 16 subsection.".
