ASSEMBLY AMENDMENT 3, TO 2011 ASSEMBLY BILL 175

February 21, 2012 – Offered by Representative August.

1	At the locations indicated, amend the bill as follows:

3	"(am) "Exclusion zone violation" means entry into an exclusion zone except for
4	purposes of traveling through an exclusion zone to get to another destination, unless
5	the person is prohibited by the department from making such entry.".
6	2. Page 3, line 23: delete "ss. 813.12 to 813.125 or enforced under s. 813.128"
7	and substitute "s. 813.12 or 813.125".
8	${f 3.}$ Page 3, line 25: delete that line and substitute "pursuant to s. 813.12 or
9	813.125.".
10	4. Page 4, line 3: delete "or 969.02 (3) (e)".
11	5. Page 4, line 4: delete lines 4 to 7 and substitute "duration of the person's
12	period of probation.".

6	having jurisdiction over the exclusion zone and the petitioner of any exclusion zone
7	violation.".

9	10. Page 5, line 7: delete "public safety" and substitute "the petitioner".
10	11. Page 5, line 8: after "department shall" insert "consider input from the
11	petitioner and shall".

13	"SECTION 5d. 813.12 (8) of the statutes is amended to read:
14	813.12 (8) PENALTY. (a) Whoever knowingly violates a temporary restraining
15	order or injunction issued under sub. (3) or (4) shall be fined not more than \$1,000
16	<u>\$10,000</u> or imprisoned for not more than 9 months or both.
17	SECTION 5r. 813.125 (7) of the statutes is amended to read:
18	813.125 (7) PENALTY. Whoever violates a temporary restraining order or
19	injunction issued under this section shall be fined not more than \$1,000 <u>\$10,000</u> or
20	imprisoned not more than 90 days or both.".
21	13. Page 6, line 18: delete "ss." and substitute "s.".
22	14. Page 6, line 18: delete "to" and substitute "or".
23	15. Page 6, line 19: delete "or any order enforced under s. 813.128".

7	20. Page 7, line 17: after "(3)" insert "(a)".
8	21. Page 7, line 18: delete "danger" and substitute "risk".

10	"(b) The court may request a domestic violence prevention or treatment center
11	in the court's county to complete a danger assessment of the person in order to make
12	the findings required in sub. (2).".

14	24. Page 7, line 24: delete ", poses a serious threat to public safety, or is likely".

17	substitute ", the court may not enter an order under sub. (1).".
18	27. Page 8, line 3: delete that line.

20	under s. 813.12 or 813.125,".
21	29. Page 8, line 17: delete "under s. 301.49 and".
22	30. Page 9, line 15: delete "ss." and substitute "s.".

5	2., for a violation punishable under s. 813.12 (8) or 813.125 (7), not less than 6 months
6	or more than the period of the injunction issued under s. 813.12 or 813.125.".

8	34. Page 10, line 24: delete "month beginning after publication" and
9	substitute "January 1, 2014".
10	35. Page 11, line 3: delete "the day after" and substitute "July 1, 2013.".
