SENATE AMENDMENT 3, TO 2011 ASSEMBLY BILL 40

June 16, 2011 – Offered by Senators Erpenbach, Carpenter, Wirch, C. Larson, Lassa, Miller, Holperin, Hansen, S. Coggs, Jauch, Risser, Taylor, Vinehout and T. Cullen.

At the locations indicated, amend the bill, as shown by assembly substitute amendment 1, as follows:

- **1.** Page 199, line 6: increase the dollar amount for fiscal year 2011–12 by \$638,700 and increase the dollar amount for fiscal year 2012–13 by \$638,700 for the purposes for which the appropriation is made.
