**ASSEMBLY AMENDMENT 5,
TO 2011 ASSEMBLY BILL 92**

May 10, 2011 – Offered by Representatives KESSLER, RICHARDS, SINICKI, ZAMARRIPA, PASCH, TURNER, DANOU, MASON, D. CULLEN, GRIGSBY, ZEPNICK, TOLES and KRUSICK.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: after “Program” insert “, changing funding of the program,”.

3 **2.** Page 2, line 1: before that line insert:

4 “**SECTION 1d.** 20.255 (2) (ac) of the statutes is amended to read:

5 20.255 (2) (ac) *General equalization aids.* The amounts in the schedule for the
6 payment of educational aids under ss. 121.08, 121.09, 121.095, and 121.105, ~~121.137~~
7 and subch. VI of ch. 121.

8 **SECTION 1h.** 74.09 (3) (dd) of the statutes is created to read:

9 74.09 (3) (dd) For Milwaukee, indicate the amount of any taxes levied to make
10 up for a reduction in general school aids as a result of the program under s. 119.23.

11 **SECTION 1p.** 74.09 (3) (gd) of the statutes is created to read:

12 74.09 (3) (gd) For Milwaukee, include a notice that provides information on the
13 financing of the program under s. 119.23.”.

1 **3.** Page 2, line 1: delete “**SECTION 1**” and substitute “**SECTION 1t**”.

2 **4.** Page 3, line 17: after that line insert:

3 “**SECTION 7b.** 119.46 (1) of the statutes is amended to read:

4 119.46 (1) As part of the budget transmitted annually to the common council
5 under s. 119.16 (8) (b), the board shall report the amount of money required for the
6 ensuing school year to operate all public schools in the city under this chapter, to
7 repair and keep in order school buildings and equipment, to make material
8 improvements to school property and to purchase necessary additions to school sites.
9 The amount included in the report for the purpose of supporting the Milwaukee
10 Parental Choice Program under s. 119.23 shall be reduced by the amount of aid
11 received by the board under s. 121.136 ~~and by the amount specified in the notice~~
12 ~~received by the board under s. 121.137 (2).~~ The common council shall levy and collect
13 a tax upon all the property subject to taxation in the city, which shall be equal to the
14 amount of money required by the board for the purposes set forth in this subsection,
15 at the same time and in the same manner as other taxes are levied and collected.
16 Such taxes shall be in addition to all other taxes which the city is authorized to levy.
17 The taxes so levied and collected, any other funds provided by law and placed at the
18 disposal of the city for the same purposes, and the moneys deposited in the school
19 operations fund under s. 119.60 (1), shall constitute the school operations fund.

20 **SECTION 7e.** 121.08 (4) (b) (intro.) of the statutes is amended to read:

21 121.08 (4) (b) (intro.) The amount of state aid that the school district operating
22 under ch. 119 is eligible to be paid from the appropriation under s. 20.255 (2) (ac) shall
23 also be reduced by the ~~amount calculated as follows~~ following percentage of the
24 amounts paid under s. 119.23 (4) and (4m) in the current school year:
