1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 2, line 1: before that line insert:
3	<b>"SECTION 1c.</b> 29.011 (3) of the statutes is amended to read:
4	29.011 (3) This section does not apply to farm-raised deer, farm-raised game
5	birds, farm-raised fish, <u>captive nonnative bears</u> , or wild animals that are subject to
6	regulation under ch. 169.
7	<b>SECTION 1e.</b> 29.047 (2) (b) of the statutes is amended to read:
8	29.047 (2) (b) The possession, transportation, delivery or receipt of farm-raised
9	deer, farm-raised game birds, farm-raised fish, <u>captive nonnative bears</u> , or wild
10	animals that are subject to regulation under ch. 169.
11	<b>SECTION 1g.</b> 29.354 (5) of the statutes, as affected by 2013 Wisconsin Act 20,
12	is amended to read:

1	29.354 (5) CAPTIVE WILD ANIMALS. This section does not apply to farm-raised
2	deer, farm–raised fish, fish produced in a municipal fish hatchery, farm–raised game
3	birds, <u>captive nonnative bears,</u> or wild animals that are subject to regulation under
4	ch. 169.
5	SECTION 1j. 29.539 (1m) (d) of the statutes, as affected by 2013 Wisconsin Act
6	20, is amended to read:
7	29.539 (1m) (d) A farm-raised deer, a farm-raised fish, fish produced in a
8	municipal fish hatchery, a farm-raised game bird, <u>a captive nonnative bear that is</u>
9	lawfully possessed, or a wild animal that is subject to regulation under ch. 169 or the
10	carcass of such a wild animal.
11	<b>SECTION 1L.</b> 29.885 (1) (f) of the statutes is amended to read:
12	29.885 (1) (f) Notwithstanding s. 29.001 (90), "wild animal" means any
13	undomesticated mammal or bird, but does not include farm-raised deer,
14	farm-raised game birds, <u>captive nonnative bears</u> , or wild animals that are subject
15	to regulation under ch. 169.
16	<b>SECTION 1n.</b> 29.889 (1) (b) of the statutes is amended to read:
17	29.889 (1) (b) Bear, other than captive nonnative bear.".
18	2. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1s".
