## SENATE AMENDMENT 1, TO SENATE BILL 267

September 11, 2013 - Offered by Senator LAZICH.

- 2. Page 2, line 9: after "residence" insert "and the name of the entity or institution that issued the identifying document".
- 5 **3.** Page 2, line 13: after "enter" insert "both".
- 4. Page 2, line 14: after "residence" insert "and the name of the entity or institution that issued the identifying document".
- **5.** Page 2, line 15: before "issue" insert "shall".
- 9 **6.** Page 3, line 18: after "<u>residence</u>" insert "<u>and the name of the entity or</u>

  10 <u>institution that issued the identifying document</u>".
- 11 **7.** Page 4, line 3: after "<u>type of</u>" insert "<u>and the name of the entity or institution</u>
  12 <u>that issued the</u>".

  - **9.** Page 5, line 1: after "enter" insert "both".
- 10. Page 5, line 1: after "residence" insert "and the name of the entity or institution that issued the identifying document".
  - **11.** Page 5, line 21: after "enter" insert "both".
- 7 **12.** Page 5, line 22: after "residence" insert "and the name of the entity or institution that issued the identifying document".
  - 13. Page 6, line 8: after "enter" insert "both".
- 10 **14.** Page 6, line 9: after "<u>residence</u>" insert "<u>and the name of the entity or</u>
  11 institution that issued the identifying document".
  - **15.** Page 6, line 15: after that line insert:
- 13 "Section 8m. 6.79 (4) of the statutes is amended to read:
  - 6.79 (4) Supplemental information. When any elector provides proof of residence under s. 6.15, 6.29 or 6.55 (2), the election officials shall enter <u>both</u> the type of identifying document provided <u>and the name of the entity or institution that issued the identifying document</u> on the poll list, or separate list maintained under sub. (2) (c). If the document submitted as proof of identity or residence includes a number which applies only to the individual holding that document, the election officials shall also enter that number on the list. When any person offering to vote has been challenged and taken the oath, following the person's name on the poll list, the officials shall enter the word "Sworn"."
