**SENATE AMENDMENT 2,
TO SENATE BILL 580**

February 13, 2014 – Offered by Senator PETROWSKI.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 “**SECTION 1d.** 51.20 (13) (cv) 4. of the statutes is amended to read:

4 51.20 (**13**) (cv) 4. If the court orders a subject individual not to possess a firearm

5 under subd. 1. or cancels under subd. 1m. c. an order issued under subd. 1. or under

6 s. 51.20 (13) (cv) 1., 2007 stats., the court clerk shall notify the department of justice

7 of that fact and provide any information identifying the subject individual that is

8 necessary to permit an accurate firearms restrictions record search under s. 175.35

9 (2g) (c), a background check under s. 175.60 (9g) (a), or an accurate response under

10 s. 165.63. No other information from the subject individual’s court records may be

11 disclosed to the department of justice except by order of the court. The department

12 of justice may disclose information provided under this subdivision only to respond

13 to a request under s. 165.63, as part of a firearms restrictions record search under

1 s. 175.35 (2g) (c) ~~or~~, under rules the department of justice promulgates under s.
2 175.35 (2g) (d), or as part of a background check under s. 175.60 (9g) (a).

3 **SECTION 1f.** 51.45 (13) (i) 4. of the statutes is amended to read:

4 51.45 (13) (i) 4. If the court orders under subd. 1. a person not to possess a
5 firearm or cancels under subd. 2. c. an order issued under subd. 1., the court clerk
6 shall notify the department of justice of the order or cancellation and provide any
7 information identifying the person that is necessary to permit an accurate firearms
8 restrictions record search under s. 175.35 (2g) (c), a background check under s.
9 175.60 (9g) (a), or an accurate response under s. 165.63. No other information from
10 the person's court records may be disclosed to the department of justice except by
11 order of the court. The department of justice may disclose information provided
12 under this subdivision only to respond to a request under s. 165.63, as part of a
13 firearms restrictions record search under s. 175.35 (2g) (c) ~~or~~, under rules the
14 department of justice promulgates under s. 175.35 (2g) (d), or as part of a background
15 check under s. 175.60 (9g) (a).

16 **SECTION 1h.** 54.10 (3) (f) 4. of the statutes is amended to read:

17 54.10 (3) (f) 4. If the court orders under subd. 1. an individual not to possess
18 a firearm or cancels under subd. 2. c. an order issued under subd. 1., the court clerk
19 shall notify the department of justice of the order or cancellation and provide any
20 information identifying the individual that is necessary to permit an accurate
21 firearms restrictions record search under s. 175.35 (2g) (c), a background check
22 under s. 175.60 (9g) (a), or an accurate response under s. 165.63. No other
23 information from the individual's court records may be disclosed to the department
24 of justice except by order of the court. The department of justice may disclose
25 information provided under this subdivision only to respond to a request under s.

1 165.63, as part of a firearms restrictions record search under s. 175.35 (2g) (c) or,
2 under rules the department of justice promulgates under s. 175.35 (2g) (d), or as part
3 of a background check under s. 175.60 (9g) (a).

4 **SECTION 1j.** 55.12 (10) (d) of the statutes is amended to read:

5 55.12 (10) (d) If the court orders under par. (a) an individual not to possess a
6 firearm or cancels under par. (b) 3. an order issued under par. (a), the court clerk shall
7 notify the department of justice of the order or cancellation and provide any
8 information identifying the individual that is necessary to permit an accurate
9 firearms restrictions record search under s. 175.35 (2g) (c), a background check
10 under s. 175.60 (9g) (a), or an accurate response under s. 165.63. No other
11 information from the individual's court records may be disclosed to the department
12 of justice except by order of the court. The department of justice may disclose
13 information provided under this paragraph only to respond to a request under s.
14 165.63, as part of a firearms restrictions record search under s. 175.35 (2g) (c) or,
15 under rules the department of justice promulgates under s. 175.35 (2g) (d), or as part
16 of a background check under s. 175.60 (9g) (a).”.

17 **2.** Page 2, line 1: delete “**SECTION 1**” and substitute “**SECTION 1q**”.

18 **3.** Page 3, line 5: delete the material beginning with “A judge” and ending with
19 “in making” on line 6 and substitute “In making”.

20 **4.** Page 3, line 8: after “(d)” insert “, a judge or court commissioner shall request
21 information under sub. (2) from the department or from a law enforcement agency
22 or law enforcement officer as provided in sub. (4) (d)”.

23 **5.** Page 3, line 15: after that line insert:
