**ASSEMBLY AMENDMENT 2,
TO ASSEMBLY BILL 142**

April 22, 2015 - Offered by Representative BERNIER.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: before that line insert:

3 “**SECTION 1d.** 66.0409 (6) of the statutes is renumbered 66.0409 (6) (a) and
4 amended to read:

5 66.0409 (6) (a) Unless other facts and circumstances that indicate a criminal
6 or malicious intent on the part of the person apply, no person may be in violation of,
7 or be charged with a violation of, an ordinance of a political subdivision relating to
8 disorderly conduct or other inappropriate behavior for loading, a firearm, or for
9 carrying, or going armed with a firearm or a knife, with the exception of a
10 switchblade knife, as defined in s. 941.24 (1g) (c), without regard to whether the
11 firearm is loaded or the firearm or the knife is concealed or openly carried. Any
12 ordinance in violation of this ~~subsection~~ paragraph does not apply and may not be
13 enforced.

1 **SECTION 1dm.** 66.0409 (6) (b) of the statutes is created to read:

2 66.0409 **(6)** (b) A person who is exempted under s. 941.24 (2m) from the
3 prohibition under s. 941.24 (1m) is not in violation of, and may not be charged with
4 a violation of, an ordinance of a political subdivision relating to disorderly conduct
5 or other inappropriate behavior for any action that the person is permitted to do
6 under s. 941.24 (2m) unless the person has a criminal or malicious intent.”.

7 **2.** Page 2, line 7: delete the material beginning with “or by gravity” and ending
8 with “movement is” on line 8 and substitute “~~or by gravity or by a thrust or movement~~
9 ~~is~~”.

10 **3.** Page 3, line 5: after that line insert:

11 “**SECTION 6m.** 947.01 (2) of the statutes is renumbered 947.01 (2) (a) and
12 amended to read:

13 947.01 **(2)** (a) Unless other facts and circumstances that indicate a criminal or
14 malicious intent on the part of the person apply, a person is not in violation of, and
15 may not be charged with a violation of, this section for loading, a firearm, or for
16 carrying, or going armed with a firearm or a knife, with the exception of a
17 switchblade knife, as defined in s. 941.24 (1g) (c), without regard to whether the
18 firearm is loaded or the firearm or the knife is concealed or openly carried.

19 **SECTION 6n.** 947.01 (2) (b) of the statutes is created to read:

20 947.01 **(2)** (b) A person who is exempted under s. 941.24 (2m) from the
21 prohibition under s. 941.24 (1m) is not in violation of, and may not be charged with
22 a violation of, this section for any action that the person is permitted to do under s.
23 941.24 (2m) unless the person has a criminal or malicious intent.”.
