**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY BILL 387**

October 15, 2015 - Offered by Representative Vos.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 10, line 17: delete "11.0202 (1) (a)" and substitute "11.0203 (1) (c)".

3 **2.** Page 15, line 2: before "accept" insert "make or".

4 **3.** Page 16, line 21: delete lines 21 to 23 and substitute:

5 "9. Any communication that does not expressly advocate for the election or
6 defeat of a clearly identified candidate.

7 10. A communication made exclusively between an organization and its
8 members. In this subdivision, a member of an organization means a shareholder,
9 employee, or officer of the organization, or an individual who has affirmatively
10 manifested an interest in joining, supporting, or aiding the organization.

11 11. Any cost incurred to conduct Internet activity by an individual acting in his
12 or her own behalf, or acting in behalf of another person if the individual is not
13 compensated specifically for those services, including the cost or value of any

1 computers, software, Internet domain names, Internet service providers, and any
2 other technology that is used to provide access to or use of the Internet, but not
3 including professional video production services purchased by the individual.

4 12. Any news story, commentary, or editorial by a broadcasting station, cable
5 television operator, producer, or programmer, Internet site, or newspaper or other
6 periodical publication, including an Internet or other electronic publication unless
7 a committee owns the medium in which news story, commentary, or editorial
8 appears.

9 13. An expenditure of funds by a sponsoring organization for a political action
10 committee's administrative or solicitation expenses.

11 14. An expenditure of funds by a sponsoring organization for an independent
12 expenditure committee's administrative or solicitation expenses.

13 15. An expenditure of funds by a sponsor, as defined in s. 11.0705 (1), for a
14 conduit's administrative or solicitation expenses.”.

15 **4.** Page 17, line 9: delete lines 9 to 12 and substitute:

16 “(b) “Disbursement” does not include any of the following:

17 1. A communication made exclusively between an organization and its
18 members. In this subdivision, a member of an organization means a shareholder,
19 employee, or officer of the organization, or an individual who has affirmatively
20 manifested an interest in joining, supporting or aiding the organization.

21 2. A communication or Internet activity by an individual acting in his or her
22 own behalf, or acting in behalf of another person if the individual is not compensated
23 specifically for those services, including the cost or value of computers, software,
24 Internet domain names, Internet service providers, and any other technology that

1 is used to provide access to or use of the Internet, but not including professional video
2 production services purchased by the individual.

3 3. Any news story, commentary, or editorial by a broadcasting station, cable
4 television operator, producer, or programmer, Internet site, or newspaper or other
5 periodical publication, including an Internet or other electronic publication unless
6 a committee owns the medium in which news story, commentary, or editorial
7 appears.

8 4. A nominal fee paid for a communication to the general public.

9 5. An expenditure of funds by a sponsoring organization for a political action
10 committee's administrative or solicitation expenses.

11 6. An expenditure of funds by a sponsoring organization for an independent
12 expenditure committee's administrative or solicitation expenses.

13 7. An expenditure of funds by a sponsor, as defined in s. 11.0705 (1), for a
14 conduit's administrative or solicitation expenses.

15 8. An expenditure of funds for a political action committee's fundraising and
16 administrative expenses.

17 9. An expenditure of funds for an independent expenditure committee's
18 fundraising and administrative expenses.

19 10. An expenditure of funds for a conduit's fundraising and administrative
20 expenses.”.

13 period on expenditures for express advocacy, expenditures made to support or defeat
14 a referendum, or contributions made to a candidate committee, legislative campaign
15 committee, or political party. In this subdivision, total spending does not include a
16 committee’s fundraising or administrative expenses.

17 (b) In this subsection, “person” does not include an individual.”.

1 2. Makes or accepts contributions or makes disbursements with regard to a
2 state or local office and to support or oppose any of the following.”.

10 (c) It does not receive contributions or make disbursements or contributions for
11 the purpose of influencing or attempting to influence a candidate’s nomination or
