**SENATE AMENDMENT 2,  
TO SENATE BILL 158**

July 6, 2015 - Offered by Senator MARKLEIN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 4, line 16: after that line insert:

3 “**SECTION 4g.** 343.065 (1) of the statutes is renumbered 343.065 (1) (a) and  
4 amended to read:

5 343.065 (1) (a) If an applicant for a commercial driver license is less than 21  
6 years of age or does not meet the physical qualifications for drivers contained in 49  
7 CFR 391 or an alternative federally approved driver qualification program  
8 established by the department by rule but is at least 18 years of age and otherwise  
9 qualified under this chapter and, subject to par. (b), the rules of the department, the  
10 department may issue the applicant a commercial driver license restricted to  
11 authorizing the operation of commercial motor vehicles not in interstate commerce.

12 **SECTION 4m.** 343.065 (1) (b) of the statutes is created to read:

1           343.065 (1) (b) An applicant with diabetes controlled by insulin is not eligible  
2 for a restricted commercial driver license under this section if the applicant had, in  
3 the 3-year period prior to the date of the application, any moving violation, or any  
4 reportable at-fault accident, due to diabetes while operating any motor vehicle. The  
5 department may not establish by rule a more restrictive eligibility standard relating  
6 to moving violations and at-fault accidents for applicants under this section who  
7 have diabetes controlled by insulin.”

8           **2.** Page 6, line 3: after that line insert:

9           “**SECTION 10m.** 343.14 (2) (im) 1m. b. of the statutes, as affected by 2015  
10 Wisconsin Act .... (this act), is amended to read:

11           343.14 (2) (im) 1m. b. ~~Meets~~ Subject to s. 343.065 (1) (b), meets all of the driver  
12 qualifications for drivers in intrastate commerce as established by the department  
13 by rule and is applying for a commercial driver license valid only in this state for  
14 noninterstate operation.”.

15           **3.** Page 12, line 6: after that line insert:

16           “(4) The renumbering and amendment of section 343.065 (1) of the statutes, the  
17 amendment of section 343.14 (2) (im) 1m. b. of the statutes, and the creation of  
18 section 343.065 (1) (b) of the statutes first apply to applications for a commercial  
19 driver license received by the department of transportation on the effective date of  
20 this subsection.”.

21           **4.** Page 12, line 7: delete lines 7 to 9 and substitute:

22           “**SECTION 36m. Effective dates.** This act takes effect on the first day of the 7th  
23 month beginning after publication, except as follows:

1           (1) The renumbering and amendment of section 343.065 (1) of the statutes, the  
2           amendment of section 343.14 (2) (im) 1m. b. of the statutes, and the creation of  
3           section 343.065 (1) (b) of the statutes and SECTION 35 (4) of this act take effect on the  
4           first day of the 4th month beginning after publication.”.
