ASSEMBLY AMENDMENT 2, TO SENATE BILL 295

February 16, 2016 - Offered by Representative Vos.

1	At the locations indicated, amend the bill, as shown by senate substitute
2	amendment 1, as follows:
3	1. Page 50, line 23: after that line insert:
4	"SECTION 100m. 11.1101 (4) of the statutes is created to read:
5	11.1101 (4) OTHER PERSONS. A person, other than a person subject to sub. (1) ,
6	(2), or (3) or s. 11.1112, may contribute to a candidate committee no more than the
7	following amounts specified for the candidate whose nomination or election the
8	committee supports:
9	(a) Candidates for governor, \$86,000.
10	(b) Candidates for lieutenant governor, \$26,000.
11	(c) Candidates for attorney general, \$44,000.
12	(d) Candidates for secretary of state, state treasurer, state superintendent, or
13	justice, \$18,000.

1	(e) Candidates for state senator, \$2,000.
2	(f) Candidates for representative to the assembly, \$1,000.
3	(g) Candidates for court of appeals judge in districts that contain a county
4	having a population of more than 500,000, \$6,000.
5	(h) Candidates for court of appeals judge in other districts, \$5,000.
6	(i) Candidates for circuit judge in circuits having a population of more than
7	300,000, or candidates for district attorney in prosecutorial units having a
8	population of more than 300,000, \$6,000.
9	(j) Candidates for circuit judge in other circuits or candidates for district
10	attorney in other prosecutorial units, \$2,000.
11	(k) Candidates for local offices, an amount equal to the greater of the following:
12	1. Four hundred dollars.
13	2. Two cents times the number of inhabitants of the jurisdiction or district,
14	according to the latest federal census or the census information on which the district
15	is based, as certified by the appropriate filing officer, but not more than \$5,000.
16	SECTION 100n. 11.1104 (3) (b) of the statutes, as affected by 2015 Wisconsin Act
17	117, is amended to read:
18	11.1104 (3) (b) A political action committee or a person subject to the limits
19	under s. 11.1101 (4) may contribute no more than \$12,000 in any calendar year to a
20	legislative campaign committee.
21	SECTION 100p. 11.1104 (4) (b) of the statutes, as affected by 2015 Wisconsin Act
22	117, is amended to read:
23	11.1104 (4) (b) A political action committee or a person subject to the limits
24	under s. 11.1101 (4) may contribute no more than \$12,000 in any calendar year to a
25	political party.".

Page 51, line 4: after "committee" insert "or a person subject to s. 11.1101 (4)".
