**ASSEMBLY AMENDMENT 9,
TO SENATE BILL 44**

March 5, 2015 - Offered by Representatives MASON, WACHS, DANOU, ZAMARRIPA, BARCA, BARNES, BERCEAU, BOWEN, BROSTOFF, CONSIDINE, DOYLE, GOYKE, HEBL, HESSELBEIN, HINTZ, JOHNSON, JORGENSEN, KAHL, KESSLER, KOLSTE, MEYERS, MILROY, OHNSTAD, POPE, RIEMER, SARGENT, SHANKLAND, SINICKI, SPREITZER, STUCK, SUBECK, C. TAYLOR, YOUNG and ZEPNICK.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 5: after “to a labor organization” insert “, membership of
3 business entities in a specified business association.”

4 **2.** Page 5, line 5: after that line insert:

5 “**SECTION 11b.** 178.40 (4) of the statutes is created to read:

6 178.40 (4) Each registered limited liability partnership shall be, without
7 payment, a full member of Wisconsin Manufacturers & Commerce. Wisconsin
8 Manufacturers & Commerce shall treat and represent all of its member businesses
9 equally, without regard to their payment of membership fees.

10 **SECTION 11f.** 179.09 of the statutes is created to read:

11 **179.09 Business association membership.** Each limited partnership shall
12 be, without payment, a full member of Wisconsin Manufacturers & Commerce.

1 Wisconsin Manufacturers & Commerce shall treat and represent all of its member
2 businesses equally, without regard to their payment of membership fees.

3 **SECTION 11k.** 180.03 of the statutes is created to read:

4 **180.03 Business association membership.** Each corporation shall be,
5 without payment, a full member of Wisconsin Manufacturers & Commerce.
6 Wisconsin Manufacturers & Commerce shall treat and represent all of its member
7 businesses equally, without regard to their payment of membership fees.

17 its member businesses equally, without regard to their payment of membership fees.

18 **SECTION 11u.** 185.047 of the statutes is created to read:

19 **185.047 Business association membership.** Each cooperative shall be,
20 without payment, a full member of Wisconsin Manufacturers & Commerce.
21 Wisconsin Manufacturers & Commerce shall treat and represent all of its member
22 businesses equally, without regard to their payment of membership fees.

23 **SECTION 11y.** 193.122 of the statutes is created to read:

24 **193.122 Business association membership.** Each cooperative shall be,
25 without payment, a full member of Wisconsin Manufacturers & Commerce.

1 Wisconsin Manufacturers & Commerce shall treat and represent all of its member
2 businesses equally, without regard to their payment of membership fees.”.
