**ASSEMBLY AMENDMENT 2,
TO ASSEMBLY BILL 307**

July 11, 2017 - Offered by Representative R. BROOKS.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 21: delete the material beginning with that line and ending with
3 page 3, line 15.

4 **2.** Page 3, line 20: delete lines 20 to 24.

5 **3.** Page 4, line 2: delete “repair, or maintenance” and substitute
6 “reconstruction, as defined in s. 84.013 (1) (c), resurfacing, as defined in s. 84.013 (1)
7 (d), or reconditioning, as defined in s. 84.013 (1) (b),”.

8 **4.** Page 6, line 20: delete “repair, or maintenance” and substitute
9 “reconstruction, as defined in s. 84.013 (1) (c), resurfacing, as defined in s. 84.013 (1)
10 (d), or reconditioning, as defined in s. 84.013 (1) (b),”.

11 **5.** Page 8, line 6: after that line insert:

12 **“SECTION 19m.** 66.1333 (5) (a) 2. of the statutes is amended to read:

1 66.1333 (5) (a) 2. Enter into any contracts determined by the authority to be
2 necessary to effectuate the purposes of this section. All contracts, other than those
3 for personal or professional services, in excess of ~~\$25,000~~ \$75,000 are subject to bid
4 and shall be awarded to the lowest qualified and competent bidder. The authority
5 may reject any bid required under this paragraph. The authority shall advertise for
6 bids by a class 2 notice, under ch. 985, published in the city in which the project is
7 to be developed. If the estimated cost of a contract, other than a contract for personal
8 or professional services, is between \$3,000 and ~~\$25,000~~ \$75,000, the authority shall
9 give a class 2 notice, under ch. 985, of the proposed work before the contract is entered
10 into.”.

11 **6.** Page 10, line 5: after that line insert:

12 “**SECTION 22m.** 200.47 (2) (a) of the statutes is amended to read:

13 200.47 (2) (a) Except as provided in par. (b), all work done and all purchases
14 of supplies and materials by the commission shall be by contract awarded to the
15 lowest responsible bidder complying with the invitation to bid, if the work or
16 purchase involves an expenditure of ~~\$20,000~~ \$75,000 or more. If the commission
17 decides to proceed with construction of any sewer after plans and specifications for
18 the sewer are completed and approved by the commission and by the department of
19 natural resources under ch. 281, the commission shall advertise by a class 2 notice
20 under ch. 985 for construction bids. All contracts and the awarding of contracts are
21 subject to s. 66.0901.”.

22 **7.** Page 10, line 8: delete “and 120.12 (5m) (b)” and substitute “120.12 (5m) (b),
23 and 200.47 (2) (a)”.
