ASSEMBLY AMENDMENT 1, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO ASSEMBLY BILL 65

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 1, line 1: delete the material beginning with that line and ending with
3	"(END)" and substitute:
4	"Section 1. 20.455 (2) (gr) of the statutes is amended to read:
5	20.455 (2) (gr) $Handgun$ $Firearm$ purchaser record check; checks for licenses or
6	certifications to carry concealed weapons. All moneys received as fee payments under
7	ss. 175.35 (2i) (a), 175.49 (5m), and 175.60 (7) (c) and (d), (13), and (15) (b) 4. a. and
8	b. to provide services under ss. 175.35, 175.49, and 175.60.
9	Section 2. 175.33 of the statutes is created to read:
10	175.33 Transfer of firearms. (1) In this section:
11	(a) "Family member" means a spouse, parent, grandparent, sibling, child, or

grandchild. The relationship may be by blood, marriage, or adoption.

- 1 (b) "Firearms dealer" has the meaning given in s. 175.35 (1) (ar).
- (2) No person may sell or transfer ownership of a firearm, or purchase or obtain
 ownership of a firearm, unless one of the following applies:
 - (a) The seller or transferor is a firearms dealer.
 - (b) The seller or transferor makes the sale or transfer to or through a firearms dealer and obtains a receipt under s. 175.35 (2j) (b).
 - (c) The sale or transfer of ownership of the firearm is one of the transfers listed under s. 175.35 (2t).
 - (d) The transferor is transferring ownership of the firearm to a family member by gift, bequest, sale, or inheritance, the transferee is not prohibited from possessing a firearm under s. 941.29, and the transferee is at least 18 years of age.
 - (e) The transferor is transferring ownership of the firearm with the intent that the transfer be temporary, neither the transferor nor the transferee is prohibited from possessing a firearm under s. 941.29, and the purpose of the transfer is not prohibited by law.
 - (3) Any person who intentionally violates sub. (2) is guilty of a misdemeanor and shall be fined not less than \$500 nor more than \$10,000 and may be imprisoned for not more than 9 months. The person is also prohibited under s. 941.29 from possessing a firearm for a period of 2 years.

restrictions record search" includes a criminal history record search, a search to determine whether a person is prohibited from possessing a firearm under s. 51.20 (13) (cv) 1., 2007 stats., a search in the national instant criminal background check system to determine whether a person has been ordered not to possess a firearm under s. 51.20 (13) (cv) 1., 51.45 (13) (i) 1., 54.10 (3) (f) 1., or 55.12 (10) (a), a search to determine whether the person is subject to an injunction under s. 813.12 or 813.122, or a tribal injunction, as defined in s. 813.12 (1) (e), issued by a court established by any federally recognized Wisconsin Indian tribe or band, except the Menominee Indian tribe of Wisconsin, that includes notice to the respondent that he or she is subject to the requirements and penalties under s. 941.29 and that has been filed with the circuit court under s. 813.128 (3g), and a search to determine whether the person is prohibited from possessing a firearm under s. 813.123 (5m) or 813.125 (4m).

175.35 (2) (am) When a firearms dealer sells <u>or transfers</u> a <u>handgun firearm</u>, he or she may not transfer possession of that <u>handgun firearm</u> to any other person until all of the <u>following have occurred</u>: <u>requirements under par. (cm) have been met.</u>

175.35 (2) (bm) When a person sells a firearm or transfers ownership of a firearm through a firearms dealer, the person may not transfer possession of that firearm to any person other than the firearms dealer, and the firearms dealer may

1	not transfer or authorize the transfer of possession of that firearm to any person,
2	until all of the requirements of par. (cm) have been met. This paragraph does not
3	apply if a person sells a firearm, or transfers ownership of a firearm, to a firearms
4	dealer.
5	Section 9. 175.35 (2) (cm) (intro.) of the statutes is created to read:
6	175.35 (2) (cm) (intro.) All of the following must occur before a sale or transfer
7	of a firearm occurs under par. (am) or (bm):
8	Section 10. 175.35 (2g) (a) of the statutes is amended to read:
9	175.35 (2g) (a) The department of justice shall promulgate rules prescribing
10	procedures for use under sub. (2) (cm) 1. for a transferee to provide and a firearms
11	dealer to inspect identification containing a photograph of the transferee.
12	Section 11. 175.35 (2g) (b) of the statutes is amended to read:
13	175.35 (2g) (b) The department of justice shall promulgate rules prescribing
14	a notification form for use under sub. (2) (cm) 2. and 3. requiring the transferee to
15	provide his or her name, date of birth, gender, race and social security number, and
16	other identification necessary to permit an accurate firearms restrictions record
17	search under par. (c) 3. and the required notification under par. (c) 4. The department
18	of justice shall make the forms available at locations throughout the state.

(c) The department may refuse to conduct firearms restrictions record searches for any firearms dealer who fails to pay any fee under this subsection par. (a) within 30 days after billing by the department.

175.35 (2i) (b) 2. If the transfer is made under sub. (2) (bm), the firearms dealer may collect from the transferor the fee under par. (a) and any additional amount to cover any costs he or she incurs in processing the transfer.

SECTION 15. 175.35 (2j) (b) of the statutes is created to read:

175.35 (2j) (b) If a person sells a firearm or transfers ownership of a firearm through a firearms dealer under sub. (2) (bm), or sells a firearm or transfers ownership of a firearm to a firearms dealer, the firearms dealer shall provide the person a written receipt documenting the dealer's participation in the sale or transfer.

175.35 (**2L**) The department of justice shall promulgate rules providing for the review of nonapprovals under sub. (2g) (c) 4. a. Any person who is denied the right to purchase a handgun <u>firearm</u> because the firearms dealer received a nonapproval number under sub. (2g) (c) 4. a. may request a firearms restrictions record search

2	person may file an appeal under rules promulgated by the department.

9	941.237 (1) (d) "Handgun" has the meaning given in s. 175.35 (1) (b) means any
10	weapon designed or redesigned, or made or remade, and intended to be fired while
11	held in one hand and to use the energy of an explosive to expel a projectile through
12	a smooth or rifled bore.
13	Section 29. 941.29 (1m) (dm), (dn) and (do) of the statutes are created to read:
14	941.29 (1m) (dm) The person has been convicted of a misdemeanor under s.

968.20 (3) (b) Except as provided in par. (a) or sub. (1m) or (4), a city, village, town or county or other custodian of a seized dangerous weapon or ammunition, if the dangerous weapon or ammunition is not required for evidence or use in further investigation and has not been disposed of pursuant to a court order at the completion of a criminal action or proceeding, shall make reasonable efforts to notify all persons who have or may have an authorized rightful interest in the dangerous weapon or ammunition of the application requirements under sub. (1). If, within 30 days after the notice, an application under sub. (1) is not made and the seized dangerous weapon or ammunition is not returned by the officer under sub. (2), the city, village, town or county or other custodian may retain the dangerous weapon or ammunition and authorize its use by a law enforcement agency, except that a dangerous weapon used in the commission of a homicide or a handgun, as defined in s. 175.35 (1) (b) 941.237 (1) (d), may not be retained. If a dangerous weapon other than a firearm is not so retained, the city, village, town or county or other custodian shall safely dispose of the dangerous weapon or, if the dangerous weapon is a motor vehicle, as defined in s. 340.01 (35), sell the motor vehicle following the procedure under s. 973.075 (4). If a firearm or ammunition is not so retained, the city, village, town or county or other custodian shall ship it to the state crime laboratories and it is then the property of the laboratories. A person designated by the department of justice may destroy any material for which the laboratories have no use or arrange for the exchange of material with other public agencies. In lieu of destruction, shoulder weapons for which the laboratory has no use shall be turned over to the department of natural resources for sale and distribution of proceeds under s. 29.934 or for use under s. 29.938.
